Dear Larry,

Harold Weisberg has sent me a copy of the letter you sent him recently (10-11-71) regarding Radio TVReports. I would like to set down here some of my reactions to that.

First, let me say, as Harold has \*\*\* probably told you, I was with Radio TV Reports for a long time, including in Chicago, and there is very little that I do not know about that company's operations during the time I was there. In addition, I still maintain contact with several people who work for RTVR, and can information about what they're into now whenever I choose. As Harold way also have told you, I put together a substantial amount of interesting material on the fim's clients while I worked there. Thru the years Harold and I have often discussed and debated possible release of this material, but have never found the right occassion. 
