My old chapter of B'nai B'rith which I was U. Pres. of is sending me half their treasury \$53.00 next week sometime. They know me & that I'll pay it back even though they don't want me too. My staying at the Y is coming from Mrs. Bernstein's own pocket now plus food too. She really can't afford it & I wouldn't like it if she could. She has other people interested but I don't want handouts. We are going to get some kosher lawyers, Doctors & help but it's going to cost. And will all get paid back real soon if we can get going into first gear first. Third & Fourth gears will involve swift action out of court ~~lawsuits~~ <sup>settlements</sup> are late dragged through the courts wipe out law suits. Like zip, zip, zip, dig!

Also I have a job waiting here where I just sit at a desk doing radium physics monkey mouse for me problems involving x-ray & Radiation therapy \$946.00 mo. I've gotten 8 other big job offers too at the Medical & Research Center here. I have orthopedic & nerve damage in my leg & the Dr.'s want to operate soon. By working at the Medical center, I can get medical follow up attention & get paid for it too. All my leg records will be back at Baylor Medical School March 12<sup>th</sup> or 13<sup>th</sup>. There is a Chicago Doctor/Director there killing himself digging in to help me. He got me employment. I can be recovering with my leg, working, earning money to help pay it all back too. I don't have any clothes here to wear to work right now. I wash them out at night by hand here &

Ⓔ put them on again in the A.M. Send ME those addresses also Dr. Berger's. I used to work with their local chapters in New Orleans, N.O. isn't authorized to help me here, it has to come from Nat. Hdq. also too many Jews back home hate my parents & would get extremely riled up if they knew about all of this. Nam. I don't need any more hell breaking out down there, I finally got them all temporarily quieted down except for their new private deal. & Scott. (next letter will have all the deals past & present & surprising solutions present & future in it) If you want to write these organizations for me from your end too, fantastic! If I can get their addresses & plus other people will be writing from this end too. There are several shock up Rabbis running around here over this I've not even met yet. They've had this type of problem here before & NEVER want it to happen again. If we show them we can & will definitely handle this problem, they'll cease attacking. Send me those addresses, I've helped enough other people in the past, I know how. Once I get answers on what to do, I can combine forces down, & we can all work together as a unit, instead of everybody running around mixed up. If you have any suggestions from past experience or can get knowledge from someone who has RUSH it to me FAST.

I am perfectly safe & have even a temporary truce with big brother, a problem I've thought of the solution to. It's a personal problem with a psychotic obsession of Godzilla's (who you don't know & don't even know what it's about. Also he is of Jewish birth himself & is leaving me alone) I know the son-of-a-bitch personally & what he wants has absolutely nothing to do with business it's strictly personal between us two arch enemies & the solution came to me in my sleep last night. And I'll handle it when I'm ready - distant future - after, long after the dust

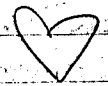

and smoke settle down here. He doesn't want me hurt, or I would have been long ago a million times over. He just wants me to say yes to something which I will NEVER do. It's strictly personal between us two alone. Now I know how I can solve it. We can go into that when we can talk in person. This has been a problem <sup>for me</sup> growing obsession with him since Nov. '68 & the solution is so simple & he would accept it & it will all end.

I told Mrs. Bernstein that you were a writer I had met and I considered you like a real parent, that you were genuine, sincere, concerned & righteous. I told her we had a guardianship relationship & that corresponding to each other in jail kept my morale lifted, because I knew you cared, really cared. I also told her that you helped other people a lot. I showed her my book of psalms I found, & how & under the circumstances I found it, that that was why it had so much meaning to me & that was why I still carry it with me always. It's just a little pamphlet book called Psalms & that's all it has in it. She is a very busy lady & will be out of town this weekend. I told her I would be all right here while she was gone, but she really worries about me & she has a beautiful head heart & soul and is a fine human being even if you aren't Jewish. She has helped others through Women in Action - non-denominational group concerned about the ~~the~~ Jail problems but can't do much. They are a non-funded vol-unteer group headquartered here at the Y. When I say I trust her with my life it is because I literally already have & she is trying to help me & could have screwed me up but doesn't want to ever. She is more than friend & wouldn't know how or be interested in being for

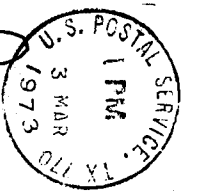
