ISOLATION 2-13-73

Dear Harold,

I am presently confined in what they call here 'isolation' (known elsewhere as solitary confinement) for a sick sadistic reason which has put every inmate in here on my side. That's how I got your letter - through jailhouse connections you'll find fantastic when I'm able to tell you. I will tell you about New Orleans incidents in TRUTHFUL detail including names + etc., but not from here, or by mail or by phone, but to your face at Route 8 which is where I'm going to come for other reasons besides, + you'd better know that it had been a very very long time since I ate because the very thought of food brought on instant nausea, all due to total disillusionment and that's coming from me, who has even faced death before + more than once. Your letter gave me an appetite. Maybe your when I come here I'll not resemble a Pakistani refugee camp which is what an engineer tells me I now look like. You ask me about Medical aid - would you believe a so called "NURSE" who gives some one a suppository to swallow, or tells someone near death with asthma attack that asthma is contagious + they are going to go into isolation for it. It would literally take an entire roll of toilet paper to list the daily things that psychos in here do to sick people. And if it gets back to her that you ever said to anyone that she was "CRAZY" you get you're butt thrown into isolation. Fact Fact. AND HERE I AM TO PROVE IT. I don't even get the Bospina a day I used to get for my fractured ankle. It is going to literally take an act of Congress to get me out of here after my parents get the letter I sent them. They aren't only going to hit the road this time, but down through it into space quicker, faster + faster than anything N.A.S.A. could ever come up with. You see Harold, if you tell a crazy person that he's crazy - it'll set them off quicker than hail. Even though I wanted to very cautiously and quoted what a prominent Louisiana Psychiatrist told them himself way back in '66 Dr. Milton Berger. Harold I'd have to tell you in person about them + then show you the letters I got from them in here + the ones I got from 3 terrified neighbors telling me about the warpath they are on, the crazy things they saying + scaring away me + death just for having ever known me. I also found out 2 people I really liked moved because of it. I'd like to tell you how they zoomed over here, hired 3 lawyers to screw me up more, because they filled their heads up with a lot of garbage + pockets with much \$\$\$ then arranged for me to get appointed a "public defender" arranged special through them, a guy who hasn't even seen me. I guess he thinks I'm so bad or something he'd better not bother. He might have even left the country. They are totally obsessed out to get me, declared Total warfare on me + it's been fermenting on their minds, and now I hope they didn't get my letter or the biggest hurricane ever hit the Louisiana swamps, that's

Cajun for "the shit hit the fan". I figure the reason it's quiet right now is because (A) they didn't get that letter or (B) it's the lull before the storm. Harold what exactly did my Father tell you on the phone that time? There were so many people running circles around him & he was so patriotic at the time that he never even got curious as to how "certain people" would come to the house with state department credentials one day - next week - be U.S. marshalls - with Justice Dept. credentials. I enjoyed it immensely & got lots of laughs out of it, also got conned, used, ripped off & hung & looking back on it all, I'm sorry you got hurt by it, because I didn't know what a true Blue friend you'd turn out to be, even in spite of what I did to you. I want you to know that I went all out to help Big Brother just to be able to watch them play games with my father's head like they did. To this day he feels like true patriot bound by sorrow even if it means torture & death. That cracks me up into hysterical laughter. I've been wanting to tell you about everything that happened over there, how I knew Big Brother & was dating one of his boys long before Jim made his little public announcement over T.V. You'd get a kick out of me telling you how I was in one of them's apt. at the time amongst 3 other's and when that came out on the news, the reaction it set off. I'm going to tell you the whole story of what I got conned into & found out, even though I'm not supposed to do a damn thing until Jim gets convicted in Fed. court, so my little conviction from him can get appealed. I got promised that it can be done & I got promised that long before they ever came up with anything on him, I figured they would too because they were red hot mad & went Gung Ho all out on it. They told me how he was a paranoid psychotic & had gotten a mental discharge from the service and many scary things. They had investigative teams, researchers, evaluators, psychologists, analysts and ALL branches of Govt. agencies working their tails off on it, and I don't know whether it was out total infuriation like they said or sheer terror on their part, but I do know how they went all out to get him. I can tell you all about that but only a little of the J.F.K. thing because that's all I know about that part of it. I was and am still scared to death of Big Jim, I'm scared to death of all psychos because you can never trust them & you never know which way they are going to go. I'd rather fight 4 big guys than one nut because I know if a nut comes after you, it'll be with 10 times the strength and hostility of anyone normal. They convinced me, he was nuts as hell too. I wish you were here now so I could tell you ALL about it and many many other things that actually happened that you don't even know about. It'll take many hours for me to tell you about that crap - the truth about it - but I know Harold you'll listen not just hear it as I tell you. And believe me some of it might give you heart failure or ulcers or both. They were experts on mind games and could make a person into a human X's Y's without them even knowing it. And they are also experts at conning people into anything and using them and then letting that person get killed for it & they would just laugh about it behind their backs. And you'll never be able to understand how vulnerable I actually was because I had been so emotionally & physically involved with Jim who later I found out was the worst of the entire bunch. It took a long long time

for me to realize how bad he really was & I loved & trusted him completely long before Big Jim broke the news & they ~~used~~ all used me like they did. To me that is completely unforgivable ever. And when I tell you the great finale they wanted me to do for them & how they hounded me & tried every thing possible to get me to do it, when you find out what it was, you'll absolutely die. It has no thing at all to do with you or Big Jim or any of that either. It was something entirely else, that they accidentally found out I could do, that I never would have walked away from, something worse than goy or bad, that would have just been a game to them, something they'd be laughing at while I was either 6 feet under or in an institution with a totally vegetated mind. They really went too far that time. I really got severely emotionally hurt because of all of them and their worse than sneaky things and was torn up all inside, scared for life afterwards but I kept quiet because I never wanted anyone to know how stupid I was and I need that deposition & those 3 tapes for my appeal but sure as hell am tired of waiting. Harold, tell you all all all about it all anytime anyway, just because I owe you that & have for a long long time plus a steak dinner which I won't buy, but will cook myself. PROMISE! SOLEMNLY SWEAR! GIRL SCOUT HONOR TOO! END FOR NOW → II I haven't heard from my lawyer in a long time, not since before I wrote you last which I don't understand at all. I sent him a letter explaining about my bad trouble since but don't know if he even got it as I haven't even received word one from him I only have the 8¢ envelope you sent me and am using it to write you with as you can see. Send me one with each letter so I can answer you. So far I owe you a lot including total honesty, a steak dinner, and now a stamped envelope and will a lot more but even though I want to give you my sincere loyalty, and you captivated my heart in a friendship way long ago by just being your genuine self. Here it is again -  - (time out for chow, now that I'm able to eat again) don't know what that was I ate & was afraid to ask. It was a slight improvement though over the Ken's Ration reject they used to give us when I first came here. They still have that Chicano cook who goes crazy with the pepper too - Thanks for giving me an appetite again Harold. Most of all, Harold, Thanks for being you. I don't know if anyone filled up my lawyer's head with a lot of garbage or what the hell is going on. Could you send him a letter from up there if I give you his address?

Tell him. This is a bad place to be in to put it mildly especially for the inexperienced - me. That I got a check back & finally cashed & can at least post bond. My parents are crazy - that you can vouch for it, ~~it~~ made things worse for me & that I could get money and lots of help from my sister and brother-in-law who is a wealthy prominent physician but don't want to ask because it would put them in the middle of Total Warfare

From my parents I have a place to stay and a job paying between  
 \$720.00 & \$900.00 a month waiting for me here in Houston at  
 Baylor Medical School and would rather pay him that way myself but  
 if he'd rather, I'll go ahead and get my sister to send him a check  
 for whatever. Tell him I want to talk it over with him first  
 though and will honor & trust his judgement and decisions totally. Tell him  
 about my past Medical trouble with my leg, that it got reinjured  
 in here & I need to have it checked by the orthopedic surgeons here in  
 Houston who already have my medical records. Tell him I have been totally  
 honest with him so far and always will be. That I need to get out of here, and  
 a registered Technician still in good standing and have a guaranteed  
 job right away and want to start earning money to pay him for  
 all he has done for me already plus all future help. Also tell him I'm  
 Jewish, belong to several organizations which will advance me emergency  
 loans but I don't know how to get in touch with them from in here.  
 Ask him why and if he'll refuse to handle my case anymore, and  
 to let me know by mail the reason and that I'll at least pay  
 him for what he has already done for me. Tell him I want to  
 know anything he has been able to find out about my case so far. Tell him  
 I need to hear from him at least by mail. Harold, would you send me a copy of the

 help me - Don't mention C.B.A.

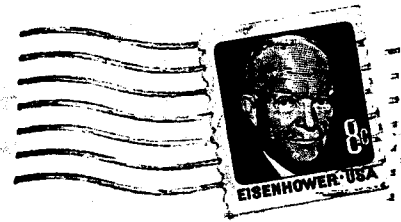
Harold, Mr. Scott knows I can write - I retained him by mail & he came to see

 what happens from here on -
