Thanks for your note of the 16th and the cassette. I'm postponing viewing it for two reasons: so that a friend who heads the history/polisci department at local Hood College can view it with me and because my impaired vision is temporarily more inpaired. Dr. Gerald McKnight teaches a course in politica 1 assassinations and all my materials will be a permanent archive there. I had the cataract memoved from my right (better) eye and for the time being don't get much good use from it. Can't drive and have to read with my left eye. It is not good enough for me to be permitted to drive.

I'm somewhat familiar with the controversy from the little that has appeared in the papers I see and from Jim. He tells me you plan a sequel to address the disputes. If I understood him correctly the denials are themselves subhect to question.

What I write for now that the show has been aired is to ask for whatever you can let me have that you did not use. I understand, for example, that you did not use what you filmed on the Douglas Jakkson story. You also have what I do not have, an account of his death. A man was quite clear in Jack White's photographic work some years ago. For your info., the Anoreseen people wefe not going to use it because their enhancement had different results.

Richter's Nova show was bad, dishonest. I've not seen John Davis' book. He's not sent me one despite the work I did and had done for him and the recordscopied for him. The Anderson show was nothing and the Kwitny show was aired only in New gfyrk City, to the best of my knowledge. I heard Jim Garrison's book is delayed until 12/15, don't know why. I've not seen Belin's newest xrap, either, and don't plan to buy it. He's sick, a real Judenrat. He and Specter debated Davis and Scheim on Kwitny. I have the saund if you'd like that but no picture.
