The remainder of that week I was back at the Archives tracing through the official versions of Oswald's movements before the killing and determined two things, which you ald not seem to have use for; one, that there were no records or estimates anywhere of what Oswald was doing in October 1963 despite the piles of evidence showing where he was at all other times before and after Kennedy was killed; and two, I found De Nohrenschildt's contradictory testimony on the letter he wrote to be auchincloss, Jackie's mother from Haiti on Dec. 12,1964 in which he said he never saw Oswald since November 1962. In fact he saw him on the Londay after Easter, April, 1963, just after Walker was shot.
