

REPLY TO SLANDERS PUBLISHED BY THE DEFAMATORY
LIBEL TITLED "DEGUELLO".

Since some time ago, an execrable and crumbly leaflet titled "Deguello" circulates among all rightist organizations of the United States and other countries. This anonymous material was printed and gratuitously distributed by first class mail, and mentioned that its authors are present or former employees of the intelligence services of several different nations of the so-called free world.

At first sight, in the first pages, the 54 leaves booklet appeared to be serious because of its solid denunciation of the Jewish-Communist conspiracy and of the objectives of world Judaism of imposing an universal domination. Undoubtedly, this first part containing the denunciation of the Jewish plot, is completely true.

The section related to the socialist conspiracy, where the Jewish origins of the different socialist and communist Internationals are exposed, is a well-known truth that is known by well-informed people, as well as certain reference made to the connections between communists and Jews with homosexuals. But as people among whom the leaflet was distributed already know these problems to a lesser or greater degree, these realities do not harm the United States Judaism at all, and were included in the defamatory material only to make readers have confidence on its veracity; so they could believe the series of odd and even criminal slanderings that - after the true former denunciation - the defamatory leaflet launches against heroic rightist patriotic leaders of the United States, as Mr. Willis A. Carto, James K. Warner, J.B. Stoner, Col. Archibald Roberts, Harry T. Everingham, Edward R. Fields and others, whose seriousness, honesty and morals are known very well by those either in or outside the United States, who know them very well since many years ago; although we may not completely agree with some of them in questions that are undoubtedly secondary, we agree in their main struggle to free the United States from the Jewish domination.

The unconfessed but clear intentions of the booklet are easily understandable at the moment it deals with the subject of the Jewish infiltration in right wing movements in the United States. It is here undoubtedly, the perverse authors of the slandering paper uncover themselves alone: they are the Jews themselves, that sometimes use bad Christians - who seek eagerly for power and are manipulated by them of who unconsciously play their game - to perform these activities.

Sacrificing themselves in certain subjects, recognizing their methods of infiltration and even admitting their own plans to establish a world government and accepting their machiavelic and evil attempts, the Jews made the so-called booklet with the purpose of dividing the American right wing, wishing to create mistrust among the conservative American leaders and to avoid that new anti-Jewish literature is distributed in the United States, taking advantage of the loss of prestige of the publication appeared under the name of "Deguello".

As a matter of fact, Judaism reached the planned and deliberated conclusion that the best way to stop the harm caused by the American patriots, was to divide the conservative field. The way they chose, as it can be easily observed, is to combine real informations with slanderings, disrepute, falsehood and rancor. The question was in other words, to use certain points of superficial differences among certain right wing groups who are, nevertheless, united in the substantial question, that is to say, in their purpose to denounce the domination over the United States of the Jewish nation infiltrated in all nations of the world, to undermine the confidence they have among themselves, creating, at the same time, an atmosphere of mistrust among the conservatives and patriots of the United States.

The tactics of Judaism, of course, could not be better. They admit a few things that hurt them, but that are well known by the people to whom the libel was directed; introducing at the same time true information, also sacrificing something in order to inspire confidence in the booklet.

Upon discovering the machiavelic Jewish trap, UDECAN took as a basis the following points to immediately alert the American patriots on the real intentions of the booklet:

1. We, the anti-communists of UDECAN, have Spanish blood in our lineage and also a particular malice to uncover the maneuvers of the inter-

national Judaism, that is perfectly known by us as well as its tactics and maneuvers, especially their use of slanderings and defaming lies as outstanding features of that people of defamers. In their books, as the "Toledot Jeshu" and others, the Jews had no scruples to slander Our Lord Jesus-Christ in different and criminal ways, as to accuse Him of living in concubinage with Magdalen and also to slander Mary, the Holy Mother of Christ, saying that She was a coarse prostitute. It is not strange, then, that Jews slander all those who attempt to free their nations from the Jewish domination, with the most coarse slanders, but spreading them throughout the country, these slanders may be believable by the useful idiots that abound everywhere.

2. The section of "Deguello" related with the Jewish activities of world domination corresponds exactly to the truth of the facts related there and is a quotation of some paragraphs of the book written by the Hungarian writer Itsvan Bakony, titled "What is Judaism?", which - because it also reveals many other recondite secrets of the Jewish communities - the United States Judaism has attempted, in different ways to avoid their publication in full, because they fear that the United States people, knowing these terrible secrets, finally decide to recover their independence from the Jewish domination that asphyxiates and even strangles them. The wide diffusion of the defamatory and nasty libel called "Deguello" is another attempt of the Israelites to avoid that an American patriot spread the book of Itsvan Bakony, "What is Judaism?" translated into English, because as the libel includes a few paragraphs of this so interesting book, mixed with slanderings and defamations against the heroic American patriots that could print and diffuse it in the United States, Judaism attempts to kill two birds with one stone: first, to avoid the printing and diffusion in the United States of a well-documented work containing the most recondite secrets of Judaism, that it does not want to be known by the American people under no circumstance. And secondly, to defame, by slandering, all those who could print and diffuse the above mentioned book of Itsvan Bakony, so they become unable to do it. Both Jewish maneuvers, nevertheless, are bound to fail, because lies and slanderings cannot prosper and because Bakony's book, as far as we know, will anyway be printed and distributed in the United States in the benefit of the noble people of this country.

3. Jews, obviously, by slandering trying to disrepute the above mentioned American right-wing leaders, attempt to provoke an adverse reaction

among conservatives, who after reading the nasty libel, could trust nobody and would not like to participate or be involved with rightist organizations soiled with mud of notoriously unbelievable and even odd slanders for us who know this heroic leaders, but that may be believed by ignorant and misinformed people although they may be well-intentioned.

4. The fact that there are certain minor differences among some American rightist movements would certainly provoke - according to the Jewish plans - a fight to death among the leaders of different groups of patriots, upon their blaming of each other of having written the defamatory leaflet.

5. The libel was written with offending lies and false intimacies that would apparently hurt the affected people and with dispersed information that would surely cause a deep division among the leaders of United States patriotic organizations.

6. "Deguello", obviously, was not the result of the work of former intelligence agents of different countries because: first, in addition with big truths it also includes so evident lies that it is impossible that former intelligence agents of different nations could believe. Furthermore, it is not signed by any former intelligence agent, so this false assertion lacks of all basis. On the other hand, the defamatory libel lacks balance.

7. Bad-intentionally, "Deguello" slanders the true patriots, omits the name of a very important one and even praises another great rightist leader, so all those slandered there suspect that these two were the ones who wrote the libel and in this way, the Jewish slanderers may cause serious divisions in the United States right wing. On the other hand, "Deguello" attempts to sow confusion among the true rightists, in order to obtain that no one knows who is better or worst.

8. The defamatory libel was apparently distributed by thousands gratuitously and with a high postal cost, aside of the considerable costs of printing and elaboration. On the other hand it is widely known that the really rightist organizations in the United States are facing difficult economic conditions to fight against the Judaical hidden power that dominate that great nation, meanwhile Jews control banks, richness, press, radio, television, school textbooks, most of the bookstores in the country and other means of influence and have available all resources to harm and launch offensive campaigns like this one.

SOME TRUE FACTS INCLUDED IN "DEGUELLO" TO MAKE READERS TRUST IT, BECAUSE ALMOST ALL OF THEM KNOW THESE TRUTHS PERFECTLY.

Undoubtedly it is true, because it is not a secret for anybody, that some organizations of the American right-wing have been infiltrated by Judaism and in other instances Jews have taken over movements to control the right wing and even the anti-communism in order to make it fail and make left triumph; or to remain infiltrated in a government when the conservative right wins in the respective elections.

Such is the case, for example, of the American Council for World Freedom (ACWF) that pretending to be an anti-communist organization, is in the hands of the Jews, with the purpose of not only achieve economic benefits from naive American conservatives, but to confuse them and carry on an absolute Jewish strategy. Marvin Liebman, Walter Judd, Lee Edwards, David Rowe, Lev Dobriansky, Possony, Schlafly and other ACWF's leaders, either Jews or not, far from being an anti-communist group, have as their objective to infiltrate and control the true patriotic and anti-communist organizations.

It is also true that the John Birch Society has outstanding Jewish members and that this organization has always avoided to deal with the subject of the Jewish-communist conspiracy, because it is under the total control of the Jewish hidden power, that in order to win prestige has included sincere and loyal patriots in the leadership of that society; they are spied by Jews infiltrated in the highest leadership of the society. Nobody doubts, also, about the false right in the hands of Jews, as it is the case of Marvin Liebman, who has the Jew Richard Viguerie and William P. Buckley, Jr., as associates, or like the Jews that lead the Young Americans for Freedom, the Draft Goldwater, the American Chilean Council and others.

It is also unquestionable that the Church League of America, led by Edgar C. Bundy, is a false rightist organization that has publicly accepted its commitments with Jews meanwhile apparently fighting communism. Same thing may be said in the known case of Billy James Hargis, although this pervert has never represented the American right-wing.

"Deguello", in other words has not succeeded in dividing, destroying or disreputing the true patriots of the United States, because those who undoubtedly are traitors and who are in the hands of Jews, are widely known and have never been identified as real patriots.

"Deguello" shows rancor, hatred and fear of the Jews, who have been little by little unmasked and exposed to the world public opinion as the aberrant and perverted racists that look forward dominating all nations that finance and support international communism and that attempt to enslave the world as one of its main objectives.

Consequently, UDECAN together with the real American patriots, will continue to fulfill its commitment with the patriotic and moral responsibility to keep on denouncing and exposing the Jewish conspiracy throughout the world.
