Frandsen told Wick that in his capacity as Chairman of the Freedom of Information Committee he had written a letter to Warren. He wondered if he had done the right thing. He said that about 10 days ago he became increasingly concerned about the Warren Commission's stifling of information and the seemingly incongruous action of Warren little by little giving snide hints of what the Commission would find, and yet at no time indicating when findings of the FBI and other investigating agencies would be made available to the American public. Frandsen therefore wrote a letter about 10 days ago asking the Chief Justice for an expression of his reasons for keeping the public in the dark and asking at what time he intended to make available to the public what newsmen are inclined to believe the American public should have based on a completed FBI investigation. He told the Chief Justice that in h s position as Chairman of the Sigma Delta Chi National Committee on Freedom of Information he would expect a reply.
