Dear Harold,

Your letter of 3/24 arrived promptly, but the letter of 4/5 took five days to get here & arrived on the 10th. I haven't been able to write to you because I was pretty sick. Spent a week in the hospital with pneumonia. I'm now convalescing at home -- can't go back to work for another 10 days.

The report on the FBI visit to Hester is very interesting.
