Program	Date	Topic
#1	7/21/94	Hal Verb interviews <u>Bob Callahan</u> on his book, <i>Who Shot JFK?</i> Discussion of the various conspiracy theories, which ones, if any, hold up - which ones don't.
#2	8/18/94	Walt Brown interviews <u>Harold Weisberg</u> - discussion of Weisberg's book, <i>Case Open</i> , and comments on Gerald Posner and his book, <i>Case Closed</i> . The tape quality is not the best but the video is pure Weisberg and puts Posner's "research" in its proper light.
#3	9/15/94	Hal Verb interviews <u>Dr. Gary Aguilar</u> . Dr. Aguilar, an expert in the medical evidence on JFK's autopsy procedures, discusses his latest findings.
#4	10/20/94	Hal Verb interviews <u>Joe Melchior</u> - Melchior, a California researcher, is queried about his research. Melchior claims that the JFK case can be tied into the Cold War propaganda campaign and offers his unique perspective on the case.
#5	11/17/94	Dave Emory interviews <u>Bill Turner</u> . Turner discusses the <u>Robert Kennedy Assassination</u> . Co-author of a book on the RFK case, he expands upon the research he's conducted on it.
#6	12/15/94	Hal Verb interviews <u>Bill O'Neil</u> and <u>Richard Goad</u> . O'Neil and Goad are California researchers. O'Neil discusses the photographic evidence and Goad offers his views on how the media has conducted itself ever since the JFK assassination.
#7	1/19/95	Bob Randolph, journalist, radio reporter and poet, interviews <u>Hal Verb</u> . Verb discusses the role of Oswald as a possible U.S. government agent and what it meant in the case of the JFK assassination.
#8	2/16/95	Hal Verb interviews <u>Roland Sheppard</u> . Sheppard was a witness to the murder of <u>Malcolm X</u> . He provides a rare insight into the slaying and offers motives for the murder.
#9	3/16/95	Hal Verb interviews <u>Doug DeSalles</u> . DeSalles is a long-time researcher, primarily on the medical evidence in the JFK assassination. He shows why the autopsy was a flawed procedure from almost its inception. Other aspects of the case are also discussed.

#10	4/20/95	Hal Verb interviews <u>Bill Bauerle</u> . Bauerle is a California researcher who has studied what he believes are Oswald's intelligence ties to the U.S. government. Was Oswald with the CIA, FBI, or . . .???
#11	5/18/95	Hal Verb interviews <u>Jay Davis</u> , California researcher. He discusses the Mannlicher-Carcano rifle and the photographic evidence implicating Oswald as the "Lone Assassin." Other topics are also discussed.
#12	6/15/95	Hal Verb interviews <u>Ian Griggs</u> . Griggs, British researcher and writer on the JFK case, discusses how the international media, press, etc., viewed the assassination. Griggs has published a compilation of these reports in a single volume, and comments on his work.
#13	7/20/95	Hal Verb reviews four recent <u>books</u> on the <u>JFK assassination</u> . The books are <i>Oswald's Tale</i> , by Norman Mailer; <i>Never Again</i> , by Harold Weisberg; <i>Oswald and the CIA</i> , by John Newman; <i>The Golden Age Is In Us</i> , by Alexander Cockburn. Cockburn's book devotes only 21 pages to the JFK case but <u>defends</u> the Warren Commission.  Reviewer Verb hits hard on the <u>Mailer</u> and <u>Cockburn</u> books.
#14	8/17/95	Hal Verb interviews <u>Bill O'Neil</u> and <u>Dr. Gary Aguilar</u> . Mr. Verb, in this final program in this series, discusses the <u>Assassination Records Review Board</u> and how it has functioned. Will it succeed or is it another whitewash?  Dr. Aguilar also discusses a reply by Dr. Wecht to a hitherto unknown memo by Dr. Boswell.
