Four Antiwar Vets Are Ordered Jailed

TALLAHASSEE, Fla. (AP) Four Vietnam Veterans Against the War were ordered back to jail today for refusing to answer questions about whether the VVAW planned violent disruptions at Miami Beach during this summer's political conventions.

cults. District Court Judge Theorem 1. Middlebrooks signed the order which directed the four to jail until they answered the questions before a grand jury, or the grand jury term expired. They had been granted immunity from prosecution.

A spokesman for the U.S. marshal's office said that as soon as the papers were formally received, the marshals would arrest the four.

Middlebrooks previously faled the four for contempt July 13. They were released July 18 on a ruling from 5th U.S. Court of Appeals which ordered another hearing. Middlebrooks held that hearing July 25.

Ordered back to jail were Wayne leverly, Austin, Tex., Joha Chambers, St. Petershurg, Fla., Jack Jennings and Bruce Horton, both of Gaines-

ville, Fla.

Six members of the VVAW were indicted earlier on charges they plotted to disrupt the Republican National Convention with bursts of gunfire and fire bombs.

But Middlebrooks' new colltempt orders cited questions about any VVAW meetings at Gainesville in May where plans were discussed about firing automatic weapons or bombing police cars, police stations and stores at Miami Beach "during any political conventions in July and August of 1972."

The four also were asked, according to the order, about any demonstrations using "crossbows, wrist rockets, slingshots and incendiary devices."

In addition to the requirement for a full hearing, the appeals court order involved reading the questions into the record.

Middlebrooks rejected a defense allegation that the government had overheard attorney-client statements by tapping telephones. He said the allegations were not specific enough. He said "the various coalitions made it 'perfectly clear' that if any violence occurs in Miami it will not be initiated by the demonstrators or the local officials in Miami Beach, but rather will be initiated by the Justice Department under the leadership of Mr. Nixon."

One major demonstration will be the third day of the convention, Schafer said.

"That will be a massive nonviolent act of civil disobedience with people sitting around the convention hall, effectively blocking the flow of delegates into and out of the convention."

He said his expectations are that thousands will be arrested there.

Acked if he did not think actions of the youthful demonstrators might provoke a reaction a g a i n s t presidential nominee George McGovern, who has closely identified with the aspirations of young people, he opined that it would not.
