Dear Mr. Weisberg:

Your letter dated January 18 to the Manager of Metromedia's Radio Station WCBM in Baltimore, Maryland, has been referred to me. At the outset, may I express my surprise that you did not contact me about your request that you be afforded time on WCBM. I am surprised simply because we have met on more than one occasion and you and I have personally discussed your book and the findings of the Warren Commission.

I am enclosing herewith a tape which includes extracts of a program on which Dr. Josiah Thompson appeared, rather than forwarding you three hours of tape. I instructed the WCBM Programming Department to extract the portions of the program where your name was mentioned and to include around those portions enough other materials so that you could get the trend of the discussion.

After reviewing this tape, I am sure that you will come to the same conclusion that I have -- that the most that is involved here is a very minor difference between experts in the field. There is nothing defamatory or in any way derogatory. Nor, in my humble opinion, does it require another appearance by you on WCBM.

You question our judgment in going far afield to present another view-point on this matter when we have the leading expert in the field readily available to us in our area. We sought out Dr. Thompson simply in order to give our listeners another analysis of the facts surrounding the assassination of our late President. We felt fully justified in doing so, inasmuch as you have appeared not only on WCBM but on all of the Metromedia television stations. Moreover, as I recall, Metromedia has telecast two programs featuring you on WTTG, so that your viewpoint on the whole episode was well aired to the viewers of the Washington-Baltimore area. Additionally, we held preview parties, where you addressed the press from both cities and explained your analysis of the assassination.

Under all of these circumstances, Mr. Weisberg, I am sure that you will acknowledge that Metromedia has treated you and your viewpoint with the utmost respect and fairness.
