I do have the Curry book. But I am always being asked for a copy by young students who have taken an interest in the subject. So, if there is no other need for ig, I can get it into the hands of someone who would have use for it.

I do not have the RFK transcripts. They and the autopsy report would be particularly valuable. I had a copy of the autopsy and it has disappeared. But I've never had the transcripts.

You may not know it but it is I who has been and is suing to bring to light the suppressed Warren Commission transcripts of their TOP SECRET executive sessions. There remain only two full transcripts and 10 pages of another than I have not yet forced out. That case is in federal court right now.

My Joesten file is in dead storage. I don't recall if it included his evaluation of Curry's book. I have 8 full-sized files asbinets in my office and five half-sized ones, so I am always pressed for space. When Joesten became inactive and I know what he has written I had to use that space for current, ongoing work, as with many other things.

As a generality I would say that anything you have that you do not need I can either use or see to it that it is available, now and in the future. People consult me often.
