I enclose a little piece on the Cahn book that I did for the Chicago Tribune's book review supplement. It might interest you.

I thought that the book was extremely well put together and, of course, its content is important. The Virginia Law Review has also asked me to review it, and I may.

Although we have never met, I know you by reputation, and I would like to mention my hope that you are not being unduly aggravated by the spate of "critiques" of the Warren Commission's Report. I reviewed Lane's book a while ago and the best I could say of it was that it "passes beyond the merely silly and superficial, being frequently dishonest as well."

Having plowed through both the Report and the exhibit volumes while working on "The Trial of Jack Ruby," I have been disgusted by the calculated dishonesty of every one of the books attacking the Report. It is most unfortunate.
