HOUSTON, TEX., NOV. 29 (AP)-CRITICS OF THE WARREN COMMISSION'S CONCLUSIONS ABOUT THE ASSASSINATION OF PRESIDENT JOHN F. KENNEDY DREW A REBUTTAL YESTERDAY FROM LEON JAWORSKI, WHO WAS SPECIAL COUNSEL IN A SEPARATE INVESTIGATION BY THE TEXAS ATTORNEY GENERAL.

JAWORSKI, MENTIONED AS A POSSIBLE CHOICE FOR U.S. ATTORNEY GENERAL, SAID YESTERDAY NEW YORK LAWYER MARK LANE'S BOOK "RUSH TO JUDGMENT," WHICH ALLEGES KENNEDY WAS VICTIM OF A CONSPIRACY, "DESERVES TO BE A BEST SELLER IN THE FICTION CATEGORY." IT HEADED THE NON-FICTION COLUMN IN THE NEW YORK TIMES BEST-SELLER LIST LAST WEEK.

THE HOUSTON LAWYER THEN LISTED POINTS WHICH HE SAID SUPPORT THE COMMISSION'S CONCLUSION THAT KENNEDY WAS KILLED AND TEXAS GOV. JOHN CONNALLY WOUNDED BY ONE MAN ACTING ALONE, LEE HARVEY OSWALD. AMONG THEM:

--THE SHOTS WERE FIRED FROM THE REAR AND CAME FROM THE TEXAS SCHOOLBOOK DEPOSITORY BUILDING. WITNESSES SAW THE BARREL OF THE RIFLE.

--ALL THE SHOTS WERE FIRED BY THE RIFLE, ACCORDING TO SCIENTIFIC TESTIMONY. CARTRIDGE CASES AND FRAGMENTS FOUND INDICATED A RIFLE LIKE THE ONE OSWALD OWNED KILLED THE PRESIDENT.

--OSWALD'S RIFLE WAS FOUND IN THE BUILDING. A CAREFUL SEARCH UNCOVERED NO OTHER WEAPON.

--BECAUSE OSWALD WORKED IN THE BUILDIG, HE WAS ABLE TO LEAVE WITHOUT SUSPICION. NO ONE WAS SEEN LEAVING THE BUILDING CARRYING A RIFLE.

"IT WOULD HAVE BEEN THE HEIGHT OF FOLLY FOR AN ASSASSIN TO LEAVE THE BUILDING CARRYING A RIFLE," JAWORSKI SAID.

OSWALD LEFT WITHOUT EVEN PAUSING TO PICK UP THE CARTRIDGE CASES EJECTED FROM HIS GUN. IF THERE WAS A SECOND ASSASSIN, JAWORSKI ASKED, WHAT HAPPENED TO HIS RIFLE? THE CARTRIDGE CASES?

--BY NATURE OSWALD WAS A LONER, ASEVIDENCE BY HIS FIGHT OVER PRO-CASTROL LEAFLETS HE

CASTRO LEAFLETS HE DISTRIBUTED IN NEW ORLEANS AND AN ATTEMPT ON GEN. EDWIN A. WALKER'S LIFE. BOTH WERE COMMITTED ALONE, JAWORSKI SAID, AND OSWALD WAS ALONE WHEN HE LEFT THE DEPOSITORY, RETURNED HOME, ARMED HIMSELF AND FLED.
