Please excuse the note-book paper! I received your note, I am very glad to hear that, yet again, your high spirits and positive outlook prevail! Max, what drives your endless optimism? Hooray for you Harold!

Judge Joe Brown was introduced to me by Cyril Wecht. I told Judge Brown that Harold Weisberg worked on the King case, and, would he be interested in any of Harold's work and pertinent info?

Judge Brown was instantly interested and asked to be gotten ahold of as soon as Harold was feeling better. As I see it, Judge Brown could use any help in this case, as the original work by you Harold is very important concerning the dynamics of the deal making and shenanigans! By the way Harold Dwyer's daughter and I were good friends in the early eighties, her name was Beatrice

And at that time she left Memphis because of bad blood between Daddy Dwyer and her. She lived with my fiance and I for a month or so!

Anyway here is a copy of Judge Brown's card, I have talked to his office, and they/he are aware that you will be writing them, or I will write for you!

I hope that soon I can be of some service to you and Gillian on the home front.

Also Harvard my research and intensive reading (31,000 pages since October 97) has brought me to some startling revelations on a personal level! It turns out that a Mr. Siragusa and QJ/WIN worked with my Father in Luxembourg and Frankfurt in '63, Sep to Dec. and my Father met with CIA's section chief in Luxembourg in early sixty four. I don't know if I told you this but my Father

at that time was a Lieutenant Colonel military intelligence. Head of collections at the I.G. FARBEN Bid. Frankfurt Germany. Dad worked sans uniform and was directly involved with CIA, ASA, DIA. I clearly remember family friends, older gentlemen who came by often. Dad told me as years progressed that many of these guys were intel operatives. Dad also in 46+47 was a Captain with C.I.C. in Wels Austria. This is where Art Kleckner and Dad worked operation Paper clip. Dad was directly involved with Reinhard Gehlen and Dornberger. I worked building homes for many of my Father's fellow intel people. I currently am working for Pete Kaliaka. FBI until '57 and then detailed to Secret Service - he did Kennedy compound Hyannis, until '62. This man was operational from '63 - 80. He is now connected with DIA. Pete is absolutely certain of conspiracy and applauds my

relentless pursuit thru this  
miasma of Smoke and Mirrors!

My Father in 1969  
went on to Long Binh, Vietnam  
and became G-2 II Field Force Victor  
directly under Gen. Abrams.

In 1970 the family (I was 13) was  
shipped to my birth place Munich  
Germany where dad became Deputy  
Commander of 66<sup>th</sup> M.I. group.

In 1971, we moved to Heidelberg  
where Dad was Head of Collections  
U.S. Army Europe military Intel.  
He ~~retired~~ retired August 74.

I forgot to add 67-69 my  
father was Pentagon QACSI, the  
top position as a full Colonel -  
sort of liaison between all U.S.  
intel agencies and military (Army)  
intel. He worked directly with the  
agency (CIA). In later years my  
father related to me, that he had  
nothing but resentment towards  
C.I.A. ~~that~~ that they were back  
stabbing glory grabbing sons-of-bitches

In fact two days before he died in 1994 my father was ordering a book on the dismantling of the C.I.A. He related that much of the work he accomplished as a top notch Intel operative was taken credit for by his counterparts in the C.I.A. He detested their unprofessional methods and their renegade recklessness. He considered their average agents skills of "TRADECRAFT" to be lacking.

I am friends with about 60-70 of his retired counterparts in Counter Intel. Many at one time they have told me what a wonderful man he was. Dad was full of integrity and was very highly decorated. It never occurred to my father to be anything but above board and straightforward. He raised four children, Betsy Sanders - third in command of the Board of Directors WALMART she's fifty four and sits on eleven Fortune 500 boards.

Susan Moenkhans, shes fifty  
and an accomplished editor in  
Saint Louis. Erika Schleifman  
shes forty seven and senior  
V.P. for Tucker Anthony brokerage  
house in D.C. Of course theresome  
forty one and an aspiring Harold  
Weisberg type! Anyhow this  
Father of mine almost certainly dealt  
with some of the very planners of  
the assassination. I also know  
he was involved in the cuba crisis  
in 61 62. Harold, Dad may have  
inadvertently stepped around on  
the periphery of the planning stages.  
As this was compartmentalized, Dad  
wouldnt have known! Its almost  
too close for home, but my Father  
wasnt a shit-bag like William  
Harvey or James J. Angleton. He  
was like you and he taught me  
compassion and the virtues of honesty.  
He also taught me never to embrace  
speculation or rootless theory'

I miss the man greatly  
but I cant help but be curious

as to those years, and what my Father may have known. I know he loved his work and he also respected greatly his commander-in chief John F. Kennedy!
