

Dear Harold,

Sovelady in it taken in the seventies.
It does appear to be the one he had ~~on~~
on at T.S.B. doorway. Why he wore
the striped garment to F.B.I. session
I don't know. Long ago I resolved the
question of the man in the doorway.

I know you find this
tedious, but concerning those tramps
(and walking on thin ice with you again?)
DPD. patrolman William Chambers
claims that he never questioned them
as stated by DPD administration.
Patrolman Ernest Beck, officers
Roy Vaughn, D.V. Harkness and officers
Bass and Wise all say deeply conflict-
ing statements both on and off the
record concerning this whole tramp
identity and where and when they
were arrested and released. No Harold
I am not saying that this is germane
to the assassination, or that this
crew was Sturgis, Hunt, or Carswell.
However, I've still reservations
concerning exactly what occurred
in the yards, the supposed interrogation
and release of what appears to be
