Enclosed the slide of the JFK shirt collar I said I'd lend you. No hurry in returning it. I've not looked at it because I gave my projector away when it was apparent I didn't need it any more.

I'm sure that it will be apparent to you that it is not possible that the slits were caused by a bullet and that they do not coincide in any way. Remember, the shirt collar was buttoned.

Remember also, this is not from any Commission photo. It is from one I got under FOIA from relindienst. He sent me an FBI original, not a copy of one.

You can see the point I made in you compare the location of these slits with the lousy picture the FBI deliberately made lousy that it gave the Commission. The nick, which is the evidence of the tie, is at the upper left extreme of theknot. So, even if the slits had been caused by a bullet that alleged bullet a) had to have made KK hole right through the middle of the knot, and there is no hole anywhere in the tie; and b) could not possibly have caused the nick to the knot.

I've not heard anything further from "im. I asked him to search for the prints and he's probably been too busy. However, I can lend you my negative, made with a Speed Graphic, if you want prints.

I'm not familiar with what HSCA published. I have it but have not read it. I took all the hearings in, by radio when not on TV, so I do not know whether it had a better picture of the tie knot than the Commission did. The Commission's, from the FBI, is so poor I recommend against making a negative and then a print from it. And it would cost less, if you cannot borrow one, to but it from the Archives. Jim doesn't remember whether I made copies and used them in the spectro case. He said he'd check.

Can you now understand why Blakey et al were so dead set against any independent checking? They knew about this, from me.

They lied to Judge Gesell when I sued for clear pictures so all he ordered them to do was to take clear pictures and let me examine them. They wrote me, as I told you, that the knot was unknotted but they did take pictures that are clear, I did examine them, and you can. If you use this, I think you should because you'll not recognize the tie from the Commission's, meaning the FBI's, print. You'll see there is no hole in the tie. And you may recall, as Baden admitted when I asked him, that when the tie and the rest was shown to your HECA panel, magically, years later, the knot had been reconstructed.
