Dear Cyril,

I'd heard that Nigel Turner had come to do something on the White fabrications for BBC but he was not in touch with me. As you say, he knows me. He has been here and he knows the magnitude of the volume of records I have and he wanted no access to any of them to check anything. Otherwise he'd have at least phoned. He also knows that I am available for debunking and he knows I believe all the pretended solutions have been misleading to the people and a disservice all around, especially in that they tend to undermine all credibility. In fact, I refused to be on his earlier show until he assumed me he'd not do any of that and then made a spectacle of himself by doing precisely that.

By this I do mean to suggest that he doesn't give a damn whether or not his White wash will be truthful or factual because he sees a spectacle in it.

I take it from your letter of the 11th that you still think there may be something to what has been concocted. I hope Turner did not get you on tape, exploiting your professional standing and expertise in any way even suggesting that there can be something to White's bull. If he did it may be embarrassing to you in time and may be used to undermine your credibility.

This is the usual problem when you take things on trust from people you believe you can trust, including their judgement - their reputation can become yours.

Please believe me, there isn't a word of fact or truth as it relates to the JFK assassination in any of that. Even the coincidences are less than Bud and his nuts say. The only real ones mean nothing, save as a reflection of the kind of woman Geneva was, to go to work for Ruby. Roscoe and Tippit were not friends who lived across the street from each other and they were never even policemen together. Roscoe was a civilian employee until after Tippit was killed. (And a thief, which is how he got those pictures.)


He and Oswald did not "serve" in the Marines together. They were both Marines and they both went to Japan on the same boat. With how many hundreds if not thousands of others!
