Dear "it was just a gig ... Maybe make a little money,"

On reading your blessedly short contribution to that it in which "PURSUIT" rather than "Truth" if capitalized, appropriately, I add, I am taken with what gives me limited choices: facing the state of my own ignorance or confirmation that you and yours are, religious trains of not, bullshit as well as ripoff artists.

Not that more confirmation was needed.

Headed "New Developments" in the Muguet, 1975 issue there is, "Dr. Cyril Wecht, corneer of Allegheny County, Pa., and a removed forensic pathologist, and Researcher Harold Weisberg have filed many, many suits through the Freedom of Information Act in an attempt to get at this information. Their persistency has begun to yield some results. In recent weeks some of the autopsy test results have been turned over to Weisberg, Dr. Wecht and others..."
