I sent Gary a page or two but I forgot to tell him then that the whole diary notion also comes from it. It has been reprinted as a paperback. That is what I borrowed.

I hope someone taped the West HoHo! and that a copy can be had.

As of today's mail I've not gotten copies of any stories on it so I presume that Gary did not send any. I'd appreciate both reading them and having them on file.

It was certainly interesting talking with you the other night.

I am sending you some of the first material I put together on the Roscoe White case. I focused on the fact that Ricky White claimed (through his mother Geneva) that "they lived across the street from the Tippits in 1964" and that "my father had to shoot his best friend (Tippit)." Since I was invited to the original press conference, I spoke to Ricky and told him I thought it impossible that Tippit was Roscoe's best friend. Billy Anglin and Murray Jackson were certainly closer. Ricky shrugged and moved off.

I knew that the phone books or Polk and Cole's references were not updated often enough to prove actual residence. I therefore started deed research. I've included all my documentation. I am still trying to chase the Hopkins connection down. I know the White's had marital problems but don't know if Geneva's living with Hopkins or return to the Pine Street apartment has any merit or validity. However, I do know that the White's were not resident on Glencairn until mid 1966, unless McGregor let Roscoe, and Roscoe let the Kattners into those respective addresses two years earlier. (Robert Groden's theory). Bottom line— A bunch of hooey!

I am also enclosing a check for \$73.75 to cover costs of the WHITEWASH series plus the M.L. King book. As we talked I wrote down the prices as \$26, \$7, \$9.75, \$7, \$12, and \$12. If this doesn't cover it let me know and I will send the balance. Could you autograph a few of them "to Dave from Harold Weisberg"? I will send more on the White's as I develop it. You probably know I am working with Gary Mack on this. The leads only tend to prove the story false.




