DALLAS (UPI) -- An extraordinary tale of the Kennedy assassination unveiled by Ricky Don White Monday has attracted a great deal of attention, but proving

it won't be easy.

The 29-year-old White says a diary that would help back up his claims was

stolen by the FBI.

White's father, rookie Dallas cop Roscoe White, who supposedly fired tw shots that killed JFK, died in what his son described as a suspicious explosion

and fire in 1971.

And Roscoe White's wife is too sick to be interviewed.

"It's a fairy tale," said David Belin, counsel to the Warren Commission which concluded in 1964 that Lee Harvey Oswald acted alone, shooting Kennedy

from the old Texas School Book Depository. "And it's a fairy tale that's a outgrowth of hallucinatory drugs."

Too many of White's details are familiar, said author Jim Moore.

Ricky White said that two Central Intelligence Agency operatives, one o whom

was code-named "Saul", also fired at the president. One was perched in the book

depository, the other in the nearby County Records Building.

Moore, whose forthcoming "Conspiracy of One" deals with the assassination,

said a 1975 book by Hugh MacDonald, "Appointment in Dallas," purported to explain the killing based on an account from a former intelligence operative.

The book never divulged the real name of the supposed agent. Instead, Moor said, the author used an imaginary code name "Saul."

One of the assassins described by MacDonald fired from the County Records

Building, a building where Moore said the relevant windows cannot and neve could be opened.

White said his father fired from the grassy knoll, hitting Kennedy from front-to-back. But Belin, who said he has had more contact with witnesses and

pathologists involved than any man alive, insists the forensic evidence proves

the bullets came from behind.

Moore, who testified before the House committee, agreed.
"It would not matter to me if Jesus Christ came down and said, 'I did
it,'

Moore said. "If he were firing from the grassy knoll, I would have some hard

questions for him."

Even those who feel Ricky White's story should be looked at are skeptical.

"I think that in order to understand the assassination of JFK, one has to be

willing to look down avenues that at first seem preposterous, even impossible,"

said Carl Henry, who has researched the assassination extensively. But he adds,

"If you've got a tiger by the tail, let's see the tiger."

the assassination site, White said.

Two other CIA operatives with code names "Lebanon" and "Saul" were stationed

in the Depository and the nearby County Records Building, he said.

CIA spokesman Mark Mansfield denied the allegations of CIA involvement. White

"was never employed by the CIA or associated in any way with the agency,"

Mansfield said. "We normally never confirm or deny employment, but these
allegations are so outrageous that we felt it was necessary and appropriat
to
respond."

White said Lee Harvey Oswald was a part of the plot, but did not fire shots.

He described Oswald and police officer J.D. Tippit, who died in the assassination aftermath, as "patsies."

The Warren Commission concluded that Oswald, acting alone, fired the shots

from the Depository that killed Kennedy and wounded John Connally, then th Texas governor. Despite the commission's findings, conspiracy theories hav abounded since the assassination.
