Interview of Philip Dale Jordan and wife Twyla

Subject answered knock on door of #220 2nd Street, S.W., Paris, Texas 75460 at 7:45 PM wearing bathrobe and appearing nervous and disheveled. He is obviously not the man in the Mexico City photograph alleged to have posed as L.H.O.

Mr. Jordan provided identification and copies of original military records and news articles, including a 1962 photograph showing him to be a slim 22 year old sailor/hero in 1962. (See attached letter of commendation dated 1/3/63 and news clipping.)

Jordan was cooperative and provided his current Texas Drivers Permit with the following:

The reported fortified compound somewhere in the Red River Valley is in fact a small run down house behind a hardware store. The front door has one lock 2 feet from the sidewalk on #220 2nd Street in downtown Paris. The small yard and adjoining building has a tall chain link fence topped with barbed wire. Mr. Jordan explained he works on upholstering autos and has the fence to protect the vehicles in the yard from "nigger thieves...there's a soup kitchen on the block."

Mr. Jordan states <sup>Abshire</sup> Ricky White is likeable and crazy, obsessed with proving his father killed J.F.K. and that he make a movie or book and money on the story. Jordan displayed a copy of the book proposal by Dick Anderson (p.s.) and characterized it as lies and inventions Ricky most definitely has convinced himself to be true.

Mr. Jordan states he used to know Geneva White when she was 14 years old. In app. 1967 Roscoe White came to him with Geneva following her hospitalization and electroshock therapy. Roscoe is said to have asked Jordan for help with Geneva because she had

lost all memory back to when she was 14 years old. She was reportedly mumbling and remembered no one other than Jordan. Jordan states that as a favor he humored her and that although her memory eventually returned she clung to the idea that Jordan was her special friend she could trust. Subsequently she provided Jordan with a sealed large brown envelope. He did not open it until the death of "Rock" and upon seeing the contents states he urged her to "turn it in to the F.B.I." He states it was the J.F.K. related photos and that in the second of three brief conversations he ever had with Roscoe, he was asked to "please keep that safe, it will be valuable some day."

Jordan stated Ricky was 10 years old when he first met him and grew up with Geneva's impression that Jordan was a special friend. Jordan also states the last time he spoke with Roscoe, he confirmed this and asked Jordan, "please look out for the kid." Despite his professed anger over Ricky's insistence that "unless you come out and confess to be the Mexico City Mystery Man, I won't have the material for a book or movie," he, Jordan, feels a bond of loyalty to keep his word and look out for him.

Jordan regards Andy Burke and Ricky to be impressionable and "off the wall."

Jordan states his being shot and home burglarized due to confused identity with D.E.A. agent, Philip D. Jordan and produced a magazine photo of the former undercover drug agent now a senior D.E.A. official who makes public appearances and has contracts out on his life by Mexican drug lords. The D.E.A. Jordan bears a strikingly similar facial appearance. Subject Jordan explains he "stuck my nose into the Route 271 Smugglers Highway drug trafficking" when his son Philip Dale Jordan was 14 and dealing drugs. He, Jordan, followed his son and stopped drug sales by being always present for 12 weeks. This resulted in his being suspected of being "a narc." (Philip Jordan II is now doing sensitive work for the Navy and received top secret clearance.)

Jordan states 2 or 3 months ago Ricky brought a friend named Joe West to his home to discuss reupholstering work. The conversation was quickly steered by White and West to the J.F.K. case. Jordan says he saw the ruse, became angry, declared he knew only what he read or saw in the media and gave them his copy of Executive Action on video tape.

#### Interview of Texas Highway Patrol Trooper John W. Williams

Trooper Williams advised he has known Jordan most of his adult life and has heard he trafficks in amphetamines. He also heard Jordan claims to be "connected to the Chicago and New York Mob," but considers this "nonsense from a blowhard driving a Harley."

### Conclusion and Analysis

Philip Jordan likely has contributed to the machinations of Ricky White's imaginative and obsessed mind on the J.F.K. subject. There is no credible evidence to believe Jordan is anything like the romanticized version of intelligence operative described in White's story.

Ricky White lied to Earl Golz and myself when he said Jordan admitted being the Mexico City Mystery Man. His wife, Patricia, when questioned, separately offered a direct contradiction.

I conclude Ricky White is not credible on numerous points, however this does not negate the significance of 1) the Marine Corps records, 2) Ruby employment, or 3) circumstances of Roscoe White's employment with the Dallas Police Department.

The fact that this Jordan story has been taken seriously by many people with so little basic work at verification is an indictment of the lack of professionalism and lack of concern for advancing insupportable allegations of complicity in the assassination.
