If you and/or Cary heard from a San Francisco radio station, KYA/KSOF as I recall, I suggested that they phone you. There was to be a Ricky White show and they phoned me. It was too late at night for me now, so they taped my responses to some questions. I think Ricky wasssupposed to have been there and that Gary Shaw replaced him but I'm not certain. Groden also was to have been there but I think he wasn't. It was the Noel Griffin show. He and I've met and I did his show when he was on a different stations several years ago, by phone.

David Real phoned me yesterday and we talked for a while. He was preparing his story for the anniversary and he was interested in researchers. I tried to distinguish between those who do actual research and that those who dream solutions and other tehories and try to make them appear real.

Of those who do neweletters I distinguished Cary from the others, pointing out that he is the only one who has consulted the pertinent records I've gotten via FOIA. I also separated Hoch, as one of the earliest and remembered that I'd first met him in the Archives in May or tune, 1966.

I also managed to avoid any personal criticisms except of Lifton and Lane.

I think that in part he planned to deal with the continuing interest in the subject and - told him how that is reflected here.

I hope that you and Gary and your families will have had a fine Thanksgiving by the time you get this, you and yours.

Please tell him about the talk show when you speak to him. They have promised me a tape of it if either of you is interested.

Hope this letter finds you well. It's time for another "monthly" update. My approach will be a little different this time. I will summarize what I have, and send the documentation later.

I have documentation for or have found the following:

- (1) A "List of Claims" dated December 19, 1972 in which Geneva White indicates her husband's net worth, at the time of his death, was \$18,526. This includes a \$10,000 life insurance policy and half the value of the White home in Richardson, Tx., also \$10,000.
- (2) A patition dated May 17, 1974 in which Geneva White states her husband was killed in a welding accident. The accident was caused in part by Arrow Chemical who provided, "No... labeling or warning... on the container... which contained a chemical which was explosive or dangerous".
- (3) A Temporary Restraining Order (# 90-053893) 165th District Court, Harris County, Texas The Matsu Corporation vs. Joe H. West and Truth, Truth, Truth, Inc. This document orders West not to do anything with "property (which) is unique, irreplaceable and priceless". J. Gary Shaw signed the order as a representative of Matsu!

- (4) Notes from the Texas Secretary of State. These notes indicate West owns at least two companies. DE-FENCE Company Inc., incorporated on 09/21/83 and Truth, Truth, Truth Inc. formed on 04/13/90. Both companies are located at 1231 Campbell, Houston, Ta. James Gary Shaw applied for a private investigators license through DE-FENCE on 05/21/90.
- (5) Matsu was incorporated on 01/25/89. Jerry Urban of the Houston Cronicle has stated that Matsu, "was created to profit from the (Ricky White) allegations".
- (6) Information from two sources. Both say that PEOPLE Magazine tested the three cables for Joe West and/or Matsu. Jerry Urban indicates that West and probably Matsu were informed that the cables were manufactured.
- (7) A verbal statement from Reverend Jack Shaw that he "never obtained a deathbed confession from Roscoe White". The AARC on page one of their August, 1990 "Update" state, "Furthermore, Rocky White confessed before his horrible death in 1971 to both his wife and his minister that he had killed JFK..."
- (8) A statement from Ron Dusek of the Texas Attorney General's Office that, "The more we look at it (the White story), the less credibility these people have".
- (S) A newspaper article from The Houston Cronicle. It says that Gary Mack has a copy of a "draft contract" between the JFK Center and Kitman Ho or Oliver Stone. The JFK Center is to receive \$80,000 for various services.
- (10) Engineering data from Liquid Carbonic Co. Ricky White verbally mis-stated the physical properties of Acetylene. In my opinion, to support his version of his father's death.

- (11) Information from four witnesses to the "fatal fire".
 They say events, as portrayed by Ricky and Geneva White, are incorrect.
- (12) Information from the doctor that gave shock treatments to Geneva White. He feels the purpose for the treatments, as noted by Rev. Jack Shaw and Ricky White, is incorrect.
- (13) Metropolitan Life and Prudential Insurance inform me that "Key Man Insurance" is paid to a company, not an employee. It was impossible for Roscoe White to sign away "Key Man Insurance" benefits. He had none in the first place.
- (14) Reports from the Dallas Police that Roscoe White could not have "disappeared" for several days after the assassination.

 "He was a rookie, had no sick time and could have been dismissed from the force."
- (15) I have discovered problems with the lie detector test administered to Ricky White:

The JFK Center now feels that question #6 is no longer important. This is probably because Ricky's answer was truthful, but incorrect. Ricky heard the story from a third party (his mother) and believed it to be accurate.

Using the same logic, at least one individual believes questions #2, #3 and #7 follow the same pattern, and have no merit.

(A) Questions #2 and #3- One can accept Ricky's statement that he read, what he thought was, his father's diary. However, there is no scientific proof that the diary is in Roscoe White's handwriting. Statements from the diary about actual events are subjective at best.

- (B) Question #7- The only evidence, I have seen, verifying Geneva White's employment by Jack Ruby, is a photograph. Geneva White has never produced payroll or income tax records to support her claim of employment by Jack Ruby.
- (C) If one reviews the test questions and responses, based upon identifiable documents, questions #1, #8, #9 and #14 are valid.
