If any of you sees anything about it, including reviews, I'd appreciate copies, for archival purposes.



As I mentioned over the phone, I became a little nervous when I saw the Jack Ruby/Geneva White photo, with a credit to the JFK Assassination Information Center. I have been researching that particular item. Geneva White claimed it was taken in September 1963. Gary Mack found the photographer to be Jimmy Rhodes and that Rhodes sold his complete collection of photos to LIFE in late 1963.

I had been trying to get the Center to show me an original print. As you know, they were never able to produce one. All they have is a half tone. After a few hours in the Dallas Public Library, I became convinced the "photo" was cut from page 44 of the November 28, 1988 issue of TIME Magazine. I contacted LIFE in an effort to get them to (1) find the original (2) flip it over and (3) tell me if a date or any names are written on the back.

Since LIFE wants \$125 an hour for research and \$750 for a copy, I worried that my snooping around would cause your magazine some problems with LIFE. I hope not, if so I'm sorry.
