
"HIS X-ray picture on the left clearly shows the front of the skull destroyed as the Warren Commission claimed. But it does

If the X-ray is that of Kennedy's shattered skull then the dead man in the other picture - published in

orner picture – published in Britain for the first time— is NOT the President. But if the X-ray – produced by the Warren Commission – is not Kennedy's skull then the United States government has taken part in a huge deception.

Wound

That is the stunning conclusion of forensic expert Professor Anthony Busuttil, of Edinburgh University.

We showed him the picture – obtained from a secret file – of President Kennedy lying on a morthagy examination table only

mortuary examination table only hours after he died.

The bullet entry wound can be seen on his temple. His face is totally intact.

The picture was also shown to
Professor Busuttil's colleague Dr
Gyan Fernardo, who had just
returned from a month-long trip
to San Antonio, Texas.
He had been studying gunshot
wounds with the help of the local
police benicide team.

At first Professor Busuttil was cautious, saying: "The X-ray picture and the side-on picture of the wound are very difficult to match."

But after consulting Dr Fer-nando he was in no doubt. "The X-ray simply does not fit

the other picture.
"ONE OF THEM IS NOT KENNEDY."

He added: "In the X-ray pic-ture there is quite a bit of bone missing around the eye, nose and cheek.

"But in the side-on picture there is no march.
"If someone had his face smashed in the fashion of the X-ray, it is highly likely the same contours would be in the actual photograph of the victim's head.
"In the shot showing the President with the throat wound on

Lee Harvey Oswald worked at the Texas Book Depository building from which he allegedly shot Kennedy.

But before that, recalled Geneva White, he had been employed at a high-security Texas military map-making company in Dallas.

Her husband was having an affair with a girl working there. Her name was Sue. "I was working at Jack Ruby's Carousel Club." she told me.

"One day I overheard Jack Ruby mention her name to Rock in his office and so I sneaked over to the

The assassination

Prof Busuttil said:
"There is so much riding on this we must prove conclusively that these are pictures of the dead President. There are simple ways of doing this."

HE widow of a former Dallas police officer has revealed her husband shot American President John F. Kennedy - on orders, she says, of the US Central Intelligence Agency.

Geneva White, now 60, told me that her husband, Roscoe, planned the assassination with small-time gangster Jack Ruby, the

planned the assassination with small-time gangster Jack Ruby, the man who shot Lee Harvey Oswald, Kennedy's alleged assassin. Mrs White, who has cancer and may die soon, claims her husband worked for the CIA and had been ordered to kill the President. He joined the Dallas police force just 17 DAYS before the President. He joined the Dallas police force just 17 DAYS before the President. He joined ten men on orders of the CIA.

"Killing the President was the hardest thing he had ever had to do. But he did his duty. The CIA claimed that President Kenpedy was a national security

nedy was a national security

Mrs White gave me this remark-able testimony at her small home in Midland, Texas, in the presence of her son Rickie, 30.

THREATS

More than two dozen people involved in the Kennedy affair have died in mysterious circumstances including Oswald, Ruby, Dallas police officer J.D. Tippet and Roscoe White.

For 27 years, Mrs White has been silent because of threats to herself and her two sons.

But now that she might not have long to live, she was ready to talk about ...

"To prove he knew my husband well, he told me private family things known only to me and Rock.

A shaken Geneva returned to Dallas,

"Rock told me he never realised when he joined the CIA what he joined the CIA what he was getting into. He didn't know that once you were in, you could never get out."

Geneva broke down after New Orleans. "I even slashed my wrists," she said.

Within a few months of ignoring the warnings to report, Roscoe White was dead, caught in a raging fireball when he lit a welding torch and suffered burns over 90 per cent of his body.
"Somebody had sabotaged the welding torch," said Geneva.
"When Rock lay dying he made a confession to our minister, the Rev. Jack Shaw, He named all the people he k ne w who were involved.
"Rock lived 25 hours. He told us it was no accident and said he had signed his own death warrant by not letting them do anything to me or the boys."

The Rev. Shaw has

thing to me or the boys."

The Rev. Shaw has verified the existence of the diary, but refused to be interviewed.

Geneva White and her son can only recall portions of the diary. They didn't copy it.

"Who would expect it to be stolen by the FBI?"
Rickie White asked.

Geneva said: "My husband wrote that he had killed ten people. He also killed Tippet.

"He said they had

"He said they had taken Tippet in as

someone that they needed inside the police

needed inside the police department.

"He wrote about 'Saul' and someone called 'Lebanon,' two other people involved, and said poor Tipper didn't have the training, and they did not intend

for him to live anyway.
"When Rock and Tip-pet got together with Oswald after the assassoswald after the assass-ination, there was some-thing Rock said that gave him away. Tipper a knew then that he wasn't going to live.

"Tippet told Rock" that he was going to have to arrest him. That's when Tippet was killed.

"When Oswald saw Rock kill Tippet, he got scared and ran, hollering that he was a passy."

patsy."
Rickie White says the diary showed that Tippet wasn't involved in killing Kennedy. "He was only doing a favour for my father – to take him and Oswald to Red Bird Field Airport."
Geneva said: "In April I suffered a cardiac arrest and the doctors told me I could die at any time. I got Rickie to bring the Rev. Shaw.

"He hypnotised me and made me remember

all these things.
"I feel like I don't
have a lot of time to live so now what I want is the truth to come out. "I'M NOT AFRAID ANY MORE."
