Joe H. West, a Certified Legal Investigator has just finished an intense, thorough investigation with the help of Gary Shaw and a large group of other researchers that includes Private Investigators.

West and Shaw will tell for the first time what really happened in Dealey Plaza on November 22, 1963 when they speak at 10:00 a.m. on May 11, 1990 in the morning session of the National Association of Legal Investigators Region IV Annual Seminar at the Key Largo Hotel in Galveston, Texas.

- ** A simple presentation of the facts. Hundreds of items not known by the public that they will document. They will show concrete evidence of other gunmen in Dealey Plaza, other shots in Dealey Plaza, gunmen escaping from Dealey Plaza. They will show: the President's wounds in his autopsy do not support the Warren Commission's or the HSCA's findings, other plots against the President and name names and how Oswald could not have committed the Tippett murder. There will be evidence of another man using Oswald's name. They will prove false reporting of Life Magazine and other media in selling the idea of Lee Harvey Oswald as the lone assassin.
- ** How the shooting occurred using photographs and eyewitnesses. They will show evidence of the suspects in the plot, giving names and background on these individuals.
- ** New evidence on eyewitnesses who saw the shots being fired on the grassy knoll.
- ** Results of their investigation concerning the murder of ROSE CHERAMI because she tried to warn two days before the assassination that Kennedy would be murdered.
- ** New evidence that <u>Houston was the original site</u> of the assassination on the day before JFK went to Dallas.
- ** Most important is that of a <u>salaried Mafia Hitman</u> who was told from first hand knowledge, exactly what happened in Dealey Plaza on November 22, 1963.
