Such Case was I furnished to the Warren Commission.

Weisborg alleges PSI misrepresented Demister's adecess to V the Warren Commission and also neglected to inform the Carren Commission

The FBI did not misropresent Danister's address. Camister's office address was 531 Lafayevte Etreet. It so happened this was a corner building and there were exite on Lafayette Etreet and on Camp Street. The latter entrance carried a Chap Street address. We sould no Indication Banister ever knew Oswald and consequently there was no reason for us to Turnish Warren Commission background caus regarding Banister.

Weisberg alleges that an unnamed witness tried to tell a Warren Commission counsel that the MEI was involved in anti-Castro Cuban groups in New Orleans but that this wittess was then threatened by It is not known whom Weisberg is referring to as this unnamed The allogation is absolutely false. Scieberg alloges that the FBI doctored a picture depicting the sixth floor window of the forms School Book Depository building where Oswald allegedly was attending. Weisberg claimed the PBI eliminated more than 30 percent of the gieture. Weisberg alleged that "J. Edgar Moover know this suppressed picture. showed the Presidential motorcade directly in front of the Texas School Book Depository Building."

It is not known what picture Weisberg is speaking of. The Pull doctored no film. We conducted exhaustive investigation in an effect to find any film depicting the Texas Echool Book Depository building sinth floor window where Oswald was stationed when the Promisons motorcate passed in front of the building. We were unsueccentu attempts to find such photograph and it appears no one possesso in oul photograph. We did, of course, locate individuals who aid not ettob or his gun in the window in question at the time the Presidentia a motorcade passed this building.
