As if the Watergate scandal and the fall of Indochina inn't enough to shatter our illusions about America, now comes the official word from General Mills:
Betty Crocker is not a real person -- and never was. General Mills Vice President Mercedes Bates admits that Betty Crocker was a fictional character created by the giant food conglomerate back in 1921. Since that time, General Mills ways, Betty Crocker has had at least five different faces to keep us with changing styles and times. And, on the heels of this Betty Crocker bombshell, Quaker Oats reports that Aunt Jemima of pancake fame never existed either. The final straw is the report from the Uncle Ben Rice Company that Uncle Ben is fictional too. Uncle Ben was dreamed up, the rice company admits, simply to stimulate the sale of long grain rice.

In the wake of mounting interest in the assasination of President Kennedy, C.B.S. is negotiating for the television rights to President Ford's book on Lee Harvey Oswald. C.B.S. is expected to finalize arrangements with M.G.M. and Now Productions this week for full T.V. rights to the book Portrait Of The Assassin was coauthored by Gerald Ford in 1965 as an answer to critics of the Warren Commission Investigation. The work is the only book ever authored by Gerald Ford -

and in it, Ford paints a picture of Oswald as being a psychologically deranged individual who was driven by personal insecurities to carry out the assassination alone. C.B.S. is expected to make a three to four-hour T.V. documentary out of the book.

Time incorporated has sold the famous Zapruder film -- the movie of the John Kennedy Assassination -- back to the family of Abraham Zapruder ... for \$1. The 8-millimeter color movie was filmed by Dallas dressmaker Abraham Zapruder on November 22nd of 1963. Immediately after the assassination, Zapruder sold the film to Time Incorporated. The original film has since never locked up in a Time Corporation vault for the past eleven years. A Zapruder family lawyer, Robert Trien, says the film will be preserved in the National Archives -- but that it will be made a vailable to serious scholars and official agencies studying the assassination.

A former staff member of the Warren Commission who is now a judge in Cleveland, Ohio, is calling for a reopening of the investigation into the assassination of President Kennedy. Judge Burt Griffin, an attorney who questioned dozens of witnesses in the J.F.K. assassination case, says: "The case ought to be reopened... it's all tied in with everything that's been happening in our government for the past ten years." The Washington Post reports that F.B.I. Director Clarence Kelley exerted behind-the-scenes pressure in an attempt to block an investigation into charges that the Mafia has successfully bribed an F.B.I. agent. The Post quotes "reliable sources" as saying that Kelley, on at least two occasions, attempted to prevent a Justice Department Strike Force from investigating the possible bribe offer. The case in question involves

Two F.B.I. agents in the New York office have told the Justice Department that Caputo paid off a third F.B.I. agent, Joseph Stabile, in an effort to stop an F.B.I. probe into Mafia activities. According to The Post, when the brillery charges were first brought against Stabile, Kelley attempted to halt the investigation by exerting pressure against the Justice Department. The Post quotes its sources as saying that Kelley was worried about the F.B.I.'s reputation being tarnished if the Mafia-bribery charge was made public.
