9/25/69 This transcript is undeted. It was while I was in N.C. I had been with Sciembre in Iven's office when he got a phone cell from Baton Rouge DA Aergent Fitcher about this pair and had not known what to say. I believe this call was to me at the Inteinbleau, afterwards, that same day. He and Brownlee had been working for the labor-management committee, having told me of it, I now believe, the previous weekend. Morris had been supposed to see me the previous weekend but couldn't bacause of car trouble that had to be rectified so they have transportation to B.R. I also had a report from a Baton Rouge reporter that Partin had phone him to say he was putting up Brownlee's bail and would delay it until the paper got a photographer there if they'd like. I gave ouis a memo on this at that time.

man: Well, we're going to go on TV and tell the man to prove all of this. That he put our life in Jeopardy.

W: That's a good way to put it.

man: Yeah.

W: He was quoted on TV as saying that.

man: Partin quoted it. It's right on -- We read the sheet down at the TV station.

W: Pikture was speaking to Moo-Moo and Moo-Moo said that he did not work for them. That they were tryingto get some information from you. That's all.

man: Okay. Well, that's what I wanted to know. Now I dinow what to do.

W: That's what Moo-Moo said. I was sitting there when he did it.

man: Because I told them I didn't know none of these people. I didn't even know magnothing about that, except maybe they had been questioning us about the assassination and that's all. We'd be the last people that Mr. Garrison would even have investigating for him.

W: Well, they knew better. I was sitting there when Moo-Moo told them.

I'll tell you what else he called for -- I was sitting with Moo-Moo when it happended -- was to find out if you had a man criminal record.

man: I told the man I had one.

W: He seemed to be interested in drugs and Moo-Moo said he didn't know this. He had heard something about a conviction for drugs and I said I didn't think that was the case.

Man: No. I have never been convicted ...

W: Neither one of you.

W: But the way he said it, you were charged...not the other one.

man: I'm going over to CBS tomorrow and I want to answerrall that man's questions and I want to answer all of them. I know they ain't going to say on TV what I got to sayat NBC but I just wanted to know what you said.

W: Yeah. Well as you know, I didn't think you had any kind of official employment. I said **khak** only that you were helping somebody and I thought it was the opposite of what they were saying.

man: Yeah.

W: So, if you did say Ball Brothers should be blown up, I said you said the opposite of it.

man: Well that's good.
All right. I'll let you know tomorrow...

W: When you all coming back?

man: I don't know. I ain't got no car. They got Morris's car confiscated.

xixix All I'm waiting to do is playing dumb. Make them prove all of this stuff. I'm going to through a lawsuit against Sheridan and Partin.

Yessir. If I can find me a lawyer. who'll do it.

W: Are you in a position to?
