ONE REFERENCE TO LAA HARVEY OSWALD WAS NOTED IN OTTAWA FILE 165-5472, CAPTIONED "REVIEW OF WARREN COMMISSION DOCUMENTS CURRENTLY BEING HELD BY THE NATIONAL ARCHIVES, IS-R." BUFILE IS NOT KNOWN BUT UNDER THAT CAPTION AND ON JANUARY 16, 1976, FBIHQ FORWARDED TO OTTAWA A COPY OF OTTAWA LETTER TO BUREAU DATED MARCH 26, 1964, AND CAPTIONED "LEE HARVEY OSWALD, IS-R-CUBA", OTTAWA FILE 163-364. THIS FILE HAD BEEN DESTROYED PER FOREIGN MANUAL OF OPERATIONS AND SOME YEARS PRIOR. THIS INFO BEING FURNISHED FBIHQ TO SHOW THAT AT ONE TIME A FILE HAD BEEN OPENED.
