Scope

Steven Blackhurst, Assistant Special Counsel for Intelligence Coordination in the Department, was contacted on 11/6/75 to determine what the Department's position would be concerning the furnishing of material relating to the Bureau's internal inquiry into the Dallas matter. Blackhurst subsequently telephonically advised SA Paul V. Daly of this Division on 11/10/75 that the Bureau should make available for review the aforementioned material for the Senate Select Committee.
