HOUSE SUBCOMMITTEE ON CIVIL AND CONSTITUTIONAL RIGHTS COMMITTEE ON THE JUDICIARY

On 11-25-75 Alan Parker, Chief Counsel, House Subcommittee on Civil and Constitutional Rights, contacted Inspector John B. Notis and requested that Special Agents James F. Hosty and Kenneth C. Howe and former SAC J. Gordon Shanklin be available for interview by members of the Subcommittee staff concerning the Bureau's investigation of the assassination of President John F. Kennedy.

SA Hosty is scheduled to appear in Washington on 12-4-75 for interview by the Senate Select Committee on the same matter. If approved, arrangements can be made for his interview on that date by House Subcommittee staff members. SA Howe and former SAC Shanklin will be interviewed on the following day, 12-5-75. Parker said the Subcommittee will make the necessary arrangements for Shanklin's travel to Washington, D. C., but asked that we notify Shanklin of the request. As you know, there is no formal agreement with the Edwards Subcommittee concerning the interview of present or former Bureau employees; however, Mr. Parker is willing to have a Bureau representative present during these interviews if we so desire and will abide by the procedures currently in effect with the Senate Select Committee. Accordingly, we will waive any employment agreements signed by Messrs. Hosty, Howe and Shanklin, but no information will be disclosed which would compromise confidential sources or techniques, jeopardize ongoing investigations or require their agency approval.

RECOMMENDATIONS

(1) That Special Agents Hosty and Howe be made available for interview by staff members of the House Subcommittee on Civil and Constitutional Rights on 12-4-75 and 12-5-75, respectively.
