Reference is made to SSC letter dated January 14, 1976, as modified at a conference on January 19, 1976, between Section Chief N. O. Cregar of the Bureau and SSC Counsel Paul G. Wallach, which letter requested delivery and/or access to various FBI materials relating to this Bureau's investigation of the assassination of President John F. Kennedy.

Item 1 requested delivery of all materials pertaining to conversations, communications or meetings during the period dovember, 1963, to December, 1964, between specified Bureau officials and any of the seven members of the Warren Commission. At the above referenced conference of January 19, 1976, it was agreed that the above request would be limited to materials relating to former Eureau officials J. Edger Hoover, Clyde Iolson, A. H. Belmont and Cartha Deloach, and that access to Bureau abstracts pertaining to such materials would constitute a satisfactory response at this time. This is to advise that the above material is available for review at FBI Headquarters by appropriate SSC personnel.

Item 2 requested information similar to that requested in Item 1, supra, only as it pertains to such contact between specified Bureau officials and any counsel or staff member of the Warren Commission. At referenced conference of January 19, 1976, it was agreed that this request would be limited to such material only

Again, it was agreed that access to Bureau abstracts pertaining to such materials would constitute, at this time, a satisfactory response to Item 2. This is to advise that the above material is available for review at FBI Headquarters by appropriate SSC personnel.

Items 10 and 11 requested all materials which discuss the question of providing or not providing the Warren Commission and/or Bureau Agents with information concerning certain stipulated areas relating to the investigation of the assassination of President Kennedy. At the above-referenced conference, it was agreed that the above requests would be modified to only cover the time period April 25, 1964, thru May 7, 1964.

Material believed responsive to Items 10 and 11, including Bureau abstracts on the subject matter during the above period, is available for review at FBI Headquarters by appropriate SSC personnel. Additionally, this Bureau is making available for review material relating to an inquiry conducted by this Bureau's Inspection Division the latter part of 1975 relating to a claim made by Special Agent James P. Hosty, Jr., in November, 1975, that certain material was not available to him in the "Oswald file" prior to his testimony before the Warren Commission.
