Lieutenant FRANCIS L. MARTELLO, Platoon Commander, First District, New Orleans Police Department, advised that on August 9, 1963 Lieutenant WILLIAM GAILLOT and Patrolmen FRANK HAYWARD and FRANK WILSON arrested LEE HARVEY OSWALD in the 700 block of Canal Street and charged him with violation of the City Ordinance relative to disturbing the peace by creating a scene. Arrested at the same time were CELSO MACARIO HERNANDEZ, CARLOS JOSE BRINGUIER and MIGUEL MARIANO CRUZ.

On the following morning about 10 a.m., August 10, 1963, Lieutenant MARTELLO noted a placard and some handbills which pertained to the Fair Play for Cuba Committee. He determined that it was the property of an arrested subject by the name of OSWALD. He asked the doorman to bring OSWALD in for an interview.

Lieutenant MARTELLO stated that as a result of this interview with OSWALD, he had made some detailed notes, which he still has in his possession, although he had not at any time dictated a report as a result of this interview. Lieutenant MARTELLO furnished the following memorandum concerning his interview of OSWALD on August 10, 1963, which he prepared as a result of a refreshment of his recollection from his original notes. Lieutenant MARTELLO remarked that his interview of OSWALD was merely for his general information and not in the nature of an official interrogation since he had been previously interviewed by the Intelligence Unit of the New Orleans Police Department.

Re Interview of LEE HARVEY OSWALD at
First District Station, New Orleans
Police Department on August 10, 1963:

"About 10 a.m. on Saturday, August 10, 1963, I observed a placard and handbills which had been placed into evidence against an accused person. This placard contained information concerning the Fair Play for Cuba Committee. I determined that a subject by the name of LEE HARVEY OSWALD was arrested on Friday, August 9, 1963 when he was passing out handbills on Canal Street and was carrying this placard about his person.

"Prior to being assigned to the First District, I had worked with the Intelligence Unit for two years and since I was generally familiar with various groups and organizations that demonstrate or picket in the city, I decided I would question this individual to see if I could develop any information which would be of value and to ascertain if all interested parties had been notified.

"I requested the doorman to bring LEE HARVEY OSWALD into the interview room. I then took the material which was to be used as evidence into this room. At the same time I reviewed the arrest record on OSWALD and determined that while he was distributing Fair Play for Cuba literature on the street, he became involved in a disturbance with CELSO MACARIO HERNANDEZ, CARLOS JOSE BRINGUIER and MIGUEL MARIANO CRUZ.

"When OSWALD was brought into the office, I introduced myself to him as Lieutenant FRANCIS L. MARTELLO and I was in uniform at the time.

"I asked OSWALD if he had any identification papers. At this time OSWALD produced his wallet. Upon my request, he removed the papers and I examined them. He had in his wallet a number of miscellaneous papers, cards and identification items. The only ones that I felt were of any significance were the following, which I made note of:

- "1. Social Security Card bearing #433-54-3937 in the name of LEE HARVEY OSWALD;
- "2. Selective Service draft card in the name of LEE HARVEY OSWALD bearing #41-114-395-32, classification - 4A.
(I do not know what draft board was registered with.)
- "3. Card bearing name LEE HARVEY OSWALD reflecting he was a member of the Fair Play for Cuba Committee; address listed as 799 Broadway, New York 3, New York; telephone #Oregon 4-8295, headquarters for Fair Play for Cuba Committee. Card was signed by V. T. LEE, Executive Secretary; card issued 5/28/63.

Sergeant HORACE J. AUSTIN, Intelligence Unit, New Orleans Police Department, advised that on August 9, 1963, he was advised by Major PRESLEY J. TROSCLAIR, JR., Intelligence Unit Commander, that he had received a telephone call from Lieutenant WILLIAM GAILLOT of the First District Police Station, that they had in custody one LEE HARVEY OSWALD who had been picked up that day for distributing Fair Play for Cuba Committee leaflets. Major TROSCLAIR instructed that AUSTIN and Patrolman WARREN ROBERTS, assigned to the same unit, interview OSWALD at the First District.

AUSTIN related that he and ROBERTS went to the First District and determined that three Cubans had been arrested with OSWALD as they were involved in a disturbance on Canal Street. These Cubans were CELSO MACARIO HERNANDEZ, CARLOS JOSE BRINGUIER, and MIGUEL MARIANO CRUZ. AUSTIN said that he conducted the interviews of BRINGUIER and CRUZ, and ROBERTS conducted the detailed interviews of OSWALD and HERNANDEZ. At the completion of these interviews AUSTIN related that he and ROBERTS got together and prepared a memorandum setting forth the details of these interviews. This memorandum was dated August 12, 1963, and is set forth in its entirety hereinafter.

"Sir:

"The following information is respectfully reported relative to the interview of four arrested subjects in the First District Police Station, beginning at about 4:45 P.M., Friday, August 9, 1963. One of the four subjects, identified as Lee Harvey Oswald, WM, age 23, residing 4907 Magazine Street, had allegedly been distributing communist literature on Canal Street, and three Cubans, the other three arrested subjects, had become involved in an altercation with Oswald, which resulted in the arrest of the four subjects.

"Lee Harvey Oswald furnished the following information when interviewed.

"He is a member of The Fair Play for Cuba Committee, whose address is 799 Broadway, New York 3, N. Y., telephone OR4-8295. Oswald had in his possession a National Membership card issued on 5/28/63, and the president's name on this card was "V. T. Lee." Oswald had also a local membership card dated 6/6/63 (N.O. Chapter of the FPFCC), and the president of the local chapter, whose name was on the card was "A. Hidell."

Oswald presented his Social Security Card, which did not bear his signature, and the number of this card was 433-54-3937.

Oswald presented his U. S. Marine Corp. discharge card (Honorable) bearing service number 1653230, and date of active duty from 24 Oct 1956 to 11 Sept. 1959.

"Oswald stated he was born in New Orleans on October 18, 1939, that he is about 5'9" tall, about 140 lbs., and is a mechanic by trade. He stated he did mechanic work in the Marine Corps, and that he is presently unemployed and has been so about three weeks. Before he was laid-off,

Oswald stated, he worked at the Louisiana Coffee Company for about three months, and before that he had worked at Fort Worth, Texas, at a sheetmetal place. Oswald stated he worked in Fort Worth at the sheetmetal place for several months, but was very evasive in answering any further questions of employment prior to that time.

"Oswald stated that he lives with his wife, whose maiden name was Marina Pross, WF, age 21. They were married in Fort Worth, have one child seventeen months of age, and reside presently at 4907 Magazine Street, lower center, Now Orleans.

"Oswald stated that he has two brothers, who reside, like his mother, in Fort Worth, Texas. He stated that his father, John Lee Oswald, is deceased.
Oswald's mother: Margarette Oswald, resides by herself in Fort Worth, Texas.
Oswald's brothers: Robert Oswald, WM, age 27,
John Oswald, WM, age 32,

"Oswald stated he had talked to Major Troclair about getting a permit for F.P.F.C.C. and the Major advised him to consult his attorney. Oswald said he never did go and see about a permit at city hall.

"Oswald further stated the Cubans came up to him where he was giving out the leaflets and began to tear them up and throw them in the street. Oswald stated that they started to yell that he was a communist and about that time the officers from the First District came up and a crowd had gathered. Oswald stated he joined the Fair Play for Cuba Committee when he found a leaflet on the street one day and read what was on it, and sent \$5.00 to the address which was in New York city and after

a brief period of time he was sent material through the mail and contacted locally, and he started to attend the meetings, which he stated were held in each others homes. Oswald stated they, the members, get together and talk about how it would be to visit Cuba, life in Cuba, etc..

"Oswald denied the organization was communist, or a communist front, when asked by Captain James Arnold, Commanding Officer of the First Police District, who came in during the interview, but Oswald had in his possession and was carrying a piece of cardboard with "VIVA VIVA Fidel" painted on it and the paraphernalia he was handing out was pasted on this cardboard also. Oswald stated he has never been to Cuba, and it appeared as though he is being used by these people and is very uninformd and knows very little about this organization that he belongs to and its ultimate purpose or goal. Oswald stated that the people that attend these informal meetings are working class people, such as clerical, trades, etc..

"The three Cubans were interviewed and furnished the following information:

#1. Colso Macario Hernandez, WM, age 47,
D.O.B. 1/8/16, Social Security Number
265-76-8756

"Hernandez stated he came to the United States via Miami, Florida, on October 9, 1962, with his family and he was a traveling book salesman in Cuba. He came to New Orleans on January 8, 1963 and resides at 519 Adele Street, New Orleans with his family. He has not had

any employment except for a few days of manual labor in Miami, Florida, and is presently on relief or welfare.

"The names of the family of Colso M. Hernandez are as follows:

- Wife: Maria De La Caridad Valero, WF, age 41 (Maiden name)
- Daughter: Maria De Los Angeles, WF, age 14
- Son: Nicholas Pablo, WM, 11
- Daughter: Terosita, WF, age 6

"Hernandez stated he saw Oswald at approximately 1:30 P.M., August 9, 1963, passing out communist literature and he went and got his friends at 107 Decatur Street and at first they were unable to locate this subject Oswald when they got on the Canal Street streetcar, and they rode to Jefferson Davis Avonue and not being able to locate Oswald they returned to 107 Decatur Street, the Casa Roca retail clothing store. They remained there until someone came in and told them where Oswald was and they then proceeded to that location, where the three of them were carrying the sign described in formation relative to Carlos Bringuier in this memo. They then began to argue with Oswald and a crowd gathered and they were all (four) arrested by the police.

"#2. Carlos Jose Bringuier, age 29, D.O.B. 6/22/34, 5'8", 150 lbs., residing 501 Adele Street, residing this address about three months, born in Hayana, Cuba.

"Bringuier stated he is manager of the Casa Roca retail clothing store, located 107 Decatur Street, New Orleans. He began his

employment about October 1, 1962.

"Bringquier previously residing at 2046 Pelopidas Street. He lives with his wife and four children.

Wife: Maria Del Carmen (Bearce), WF, age 25
Born in Argentina, Buenos Aires
Married in Buenos Aires, April 14, 1956
Entered U. S. February 8, 1961, at Miami, Florida, by plane.
Wife entered U. S. in Miami in May, 1961.
Ages of children are 6, 5, 3 and 2.

Julio and Vicenta Bringquier, mother and father, reside at 1769 S. W. 17th. Street, Miami, Florida, Bringquier stated.

Julio was born in 1895 in Remedios, Cuba, entered the U. S. after invasion, believed by Bringquier to be in May of 1961.

Vicenta was born in 1894 in Moron, Cuba, and entered the U. S. with Julio.

Carlos Bringquier gave the following names of his brothers and sisters:

"Julio Enrique Bringquier, (brother), age 41, born Moron, Cuba, now residing 1769 SW. 17th. Street, Miami, entered the U. S. at end of 1961.

"Maria Gertrudis (Pelaez) age 42, (sister), resides 2224 Mendez Street, married to Rolando Pelaez, who also works at the Casa Roca clothing store, 107 Decatur Street, New Orleans.

"Juan Felipe Bringquier, age 35, (brother), born in Cuba, entered the U. S. December 24, 1962, resides in New York City, is unmarried.

"Maria Del Carmen (Modina), age 39, (sister), married to Jorge Modina, age 41, who is in Cuba. Maria Del Carmen lives in Iberville project in New Orleans, believed to be on Iberville Street. Jorge Modina was working in Criminal Court in Havana, went crazy.

"Carlos Jose Bringuiet also gave the following information relating to himself.

His social security number 435-64-3717,

His selective service number 16 42 34 462, classified 5-A, local board #42, New Orleans, dated August 24, 1961

Possesses Louisiana drivers license number 1585883, date of issue 2/26/62, address on license 4525 Duplessis Street.

Possesses Immigrant Resident card #A 12 546 223, dated 2/8/61

"Bringuiet further stated that he is a local delegate of the CUBAN STUDENT DIRECTORATE, in City of New Orleans, appointed by one Jose Antonio Lanuza, Secretary, American Affairs, Cuban Student Directorate, P.O. Box 805, Main Post Office, Miami, Florida, telephone Franklin 3-1476.

"Bringuiet stated that his first job in New Orleans was with the California Redwood Produce Co., on S. Peters Street, owned by Mr. L. C. Levy. Bringuiet stated he worked here two days.

"Bringuiet then worked at Mac's Discount House, located at 714 Canal Street, for about one year, beginning April 1, 1961.

"Bringuiet then became a self employed pedler in April of 1962 with his brother-in-law, Rolando Pelaez. They bought clothing and radios wholesale and went aboard ships to sell same. Bringuiet stated that he had a Port Security Card.

"Bringuiet then stated that on October 1, 1962, he opened the Casa Roca clothing store, 107 Decatur Street, and has been working here until this date.

"Bringuier stated that he keeps the sign, in the Cuban's possession at the time of arrest this date, in his store. This sign measures about 3 feet by 4 feet, with a picture of the Statue of Liberty, hand with dagger on end of long chain, and Cuba ringed by two links of the chain. The sign reads "Danger! Only 90 miles from U.S.A., Cuba lies in chains!"

"Bringuier stated that the sign was given to him by Arnesto Rodriguez, age in his 30's, who resided at 1203 St. Charles Street in New Orleans, at the time Arturo Frondizi came to New Orleans in January or February of 1962. Bringuier believes Frondizi is a communist, and he has two brothers in Argentina who are Communists.

"Bringuier further stated that he came to New Orleans right from Miami, Florida, by Greyhound bus, arriving in New Orleans on February 18, 1961.

"#3. Miguel Mariano Cruz, age 18, D.O.B. 9/27/44, residing 2526 Mazant Street, New Orleans, unmarried, lives with mother, father and three sisters.

Mother: Victoriana (Enriquez) Cruz, age 56

Father: Claudio Cruz, age 64, unemployed, on Welfare.

Sisters: Hordonsia Maria Cruz, age 26, a student at Capelle Beauty School, 1509 St. Charles Avenue.

Ina Josefa Cruz, age 25, stays at home.

Maria Toresa Cruz, age 19, works at a petroleum company at night.

Date 11/26/63

Mrs. MARCELLE MADDEN, Identification Division, New Orleans Police Department stated that her files did reflect a record on LEE HARVEY OSWALD, New Orleans Police Department Number 112-723. She stated that arrest report, number 645, prepared by First District under Item H-4843-63, showed that OSWALD was arrested on August 9, 1963 at 4:15 PM at the 700 block of Canal Street. He was arrested by Lieutenant W. GAILLOT and Patrolmen F. HAYWARD and F. WILSON of the First District and charged with violation of City Ordinance 828MCS 42-22, relative to disturbing the peace by creating a scene.

Mrs. MADDEN said that OSWALD's residence at that time was indicated as 4907 Magazine Street, New Orleans, Louisiana.

He was described as follows:

She said the report showed he was arrested with CARLOS BRINGUIER, CELSO M. HERNANDEZ and MIGUEL M. CRUZ.

Under remarks in this report, Mrs. MADDEN stated was the following:

"This subject is a member of the Fair Play for Cuba, which upholds Fidel Castro. This subject was passing circulars in the 700 block of Canal Street when he became involved in a disturbance with three Cuban immigrants."

Mr. JOSEPH B. ~~TONER~~, manager, New Orleans Retailers' Credit Bureau, Inc., Masonic Temple Building, advised that Mr. J. D. VINSON of the Isaac Detective Agency, Room 608 Richards Building, New Orleans, had come to the credit bureau on November 27, 1963 and requested that the following names be checked through the files:

Mr. TONER stated he told Mr. VINSON that his inquiry regarding OSWALD would be reported to the New Orleans FBI Office.

Mr. J. D. VINSON, Isaac Detective Agency, Room 608 Richards Building, informed that a client of his had called him on November 22, 1963 and advised he had heard over the television that the assassin of President JOHN F. KENNEDY was LEE HARVEY OSWALD. His client requested that he check his files and furnish him with any information with respect to OSWALD.

Mr. VINSON reluctantly advised that his client was JACK N. ROGERS, legal counsel for the Joint Legislative Committee on Un-American Activities for the State of Louisiana at Baton Rouge, Louisiana.

VINSON stated his files contain nothing concerning LEE HARVEY OSWALD or anything with reference to the assassination of the President. He stated that since his files did not contain any information, he decided to go to the New Orleans Retailers' Credit Bureau to check their records. He said in addition to checking the name of OSWALD, he also requested a check on ROBERT LEE OSWALD, brother of LEE HARVEY OSWALD, and the name A. J. HIDEELL, Post Office Box 30016, which individual was allegedly affiliated with OSWALD, according to news releases.

VINSON said he also checked the name of CARLOS BRINGUIER, 501 Adell Street, to see if the credit bureau had anything on him since he recalled that in August, 1963, OSWALD had been involved in a fight with this individual, who was a Cuban, while OSWALD was distributing Fair Play for Cuba Committee literature on Canal Street. Mr. VINSON said he also checked the names of FORREST E. LA VIOLETTE and LEONARD REISSMAN since he had a dim recollection that sometime in 1962, date not recalled, some Fair Play for Cuba literature had been found in the street in the 1200 or 1300 block of Pine Street in New Orleans. He said he had, in the past, checked the New Orleans City Directory and found that LA VIOLETTE lived at 1307 Pine and REISSMAN resided at 1121 Pine and were professors at Tulane University. Whether these individuals were connected with the Fair Play for Cuba Committee he could not state and had no basis for belief that they were so associated; however, he felt that a credit check on them may reveal something which would be of interest to himself as well as his client, ROGERS. He maintained he had no

information on any of these people in his file but was attempting to develop information with regard to them.

Mr. VINSON said he did not intend to make any further inquiry on OSWALD or any of the other individuals mentioned above and as yet had not been in contact with his client, ROGERS, to inform him that he had developed no information on OSWALD.

PHILIP GERACI, 2201 Green Acres Road, furnished the following information:

GERACI viewed a photograph of LEE HARVEY OSWALD and stated OSWALD was identical to an individual with whom he had a brief conversation lasting about ten minutes, which took place at the Cuban Student Directorate (CSD), 107 Decatur Street, New Orleans, in the latter part of July, 1963. GERACI, age 15, a sophomore at East Jefferson High School, Metairie, Louisiana, advised that at the time he met OSWALD at the CSD he, GERACI, was visiting that place for the first time for the purpose of obtaining information regarding the CSD, which he had heard was an anti-CASTRO Cuban organization. GERACI stated that he discussed anti-CASTRO activities with a CARLOS BRINGIUS (phonetic), who owned the Casa Roca Store, 107 Decatur Street, which was the headquarters for the anti-CASTRO organization, known as the CSD. Accompanying GERACI at that time was a friend of his, VANCE BLALOCK, 5708 Boutall Street, Metairie, Louisiana.

While talking with CARLOS BRINGIUS, an individual whose photograph GERACI advised was identical to LEE HARVEY OSWALD, came into the store and made inquiry of BRINGIUS regarding anti-CASTRO literature. OSWALD expressed an interest in learning all about the CSD and indicated a desire to join the organization. Following a brief discussion of the CSD, its purposes and objectives, OSWALD became engaged in another conversation with GERACI and his friend, BLALOCK. GERACI recalls OSWALD mentioning that he had in his possession a Marine Guide Book which contained information regarding guerrilla tactics, firearms and other subjects. GERACI recalls mentioning to OSWALD that he, GERACI, had done a little reading regarding guerrilla warfare, after which OSWALD informed him that he was familiar with various types of guerrilla tactics. OSWALD informed GERACI that he knew enough about explosives to be able to blow up the new bridge which crossed the Mississippi River from New Orleans to Algiers, Louisiana. OSWALD also mentioned that he knew how to derail a train which could easily be accomplished by placing a chain around the railroad tracks and securing it with a lock.

WILLIAM K. STUCKEY, The Ross Agency, Inc., 525 Gravier Street, residence address 2317 State Street, furnished the following information:

He called at the OSWALD apartment alone, 4905 Magazine Street, at about 8:00 a.m. on August 17, 1963, to invite him to appear on his radio program. OSWALD agreed and STUCKEY told OSWALD to meet him at WDSU Radio Studios, 520 Royal Street, between 4:30 and 5:00 p.m. He stated that his conversation with OSWALD took place on the front porch of OSWALD's apartment and that during the conversation, OSWALD showed him his membership card in the Fair Play for Cuba Committee, which was signed by A. J. HIDEELL. He did not know anyone named PETE MOLLAR. Mr. STUCKEY advised that he had never met A. J. HIDEELL and from his conversation with OSWALD, came to the conclusion that HIDEELL is a fictitious name or an alias used by OSWALD.

STUCKEY stated that an unpublished and unreleased interview with OSWALD was then recorded on tape. The interview lasted for about 37 minutes. He said that officials of the radio station thought that the interview was too long for an interesting program and that he used excerpts from this taped interview on a program known as Latin Listening Post that night. He stated that he then arranged a question and answer program with OSWALD for the evening of August 21, 1963 over Radio Station WDSU. On this program, he invited EDWARD SCANNELL BUTLER, Staff Director for the Information Council of the Americas, CARLOS BRANQUIER, Director of the Student Cuba Directorate for the New Orleans area. This program was broadcasted at 6:05 p.m. on August 21, 1963, in a program entitled, "Conversation Carte Blanche". It was during the latter program that OSWALD stated that the Fair Play for Cuba Committee was not communist controlled and that he, OSWALD, was a Marxist.

CARLOS BRINGUIER, Cuban Student Directorate, Operator of the Casa Roca Clothing Store, 107 Decatur Street, advised that on August 5, 1963, OSWALD came into his store and gave him a Marine guide book, stating he was an ex-Marine who could fight against CASTRO and if needed, could help train guerrillas. He put his hand in his pocket as if to contribute money to the Cuban Student Directorate, but BRINGUIER stopped him and told him he could not accept contributions and that he was the only member of the Directorate in New Orleans. OSWALD told him not to lie about it, that "we" can infiltrate you, at which time BRINGUIER became suspicious of OSWALD and would talk no more with him.

He stated he again saw OSWALD on August 9, 1963, when OSWALD was arrested after OSWALD tried to distribute Fair Play for Cuba Committee (FPCC) handbills on Canal Street. BRINGUIER again saw OSWALD at OSWALD's trial in Municipal Court August 12, 1963, and then saw him at 6:00 PM, August 21, 1963, at the debate in which OSWALD participated over radio station WDSU in New Orleans.

BRINGUIER claims he has no information regarding anyone named HIDEELL, JACK RUBY, JACK RUBENSTEIN, nor any other information regarding FPCC, New Orleans. He stated that the two anti-CASTRO Cubans arrested on August 9, 1963, in the altercation with OSWALD had only that contact with OSWALD.

BRINGUIER stated that he had learned from talking with ORESTES PENA, Proprietor of the Habana Bar, 117 Decatur Street, that OSWALD was apparently in the Bar some time between the 15th and 30th of August, 1963, with a Mexican individual, name not known. This Mexican was later seen in the Bar with another Mexican. He also said that from talking with PENA, OSWALD may have frequented the restaurant on the corner of Iberville and Decatur Streets.

CARLOS BRINGUIER, Casa Roca, 107 Decatur Street, displayed the copy of the booklet which bore the name at the top, Basic Pamphlets (14) "The Crime Against Cuba" by CORLISS LAMONT. This pamphlet was printed by Basic Pamphlets, Box 42, Cathedral Street, New York 25, New York.

BRINGUIER made available a copy of the application to the FPCC, New Orleans, Louisiana, which reads as follows:

Confidential Informant NO T-5 furnished the following on November 27, 1963:

He is acquainted with CARLOS BRINGUIER, Cuban Student Directorate, New Orleans, and was aware of the arrest of BRINGUIER and two other Cubans along with LEE HARVEY OSWALD on August 9, 1963, when OSWALD passed out Fair Play for Cuba (FPCC) handbills on Canal Street. Approximately a week later (August 16, 1963), he was seated in Thompson's Restaurant when the Representative of Puerto Rico, who has his office in the International Trade Mart, showed him an FPCC handbill, telling him these handbills were being passed out in front of the International Trade Mart. NO T-5 notified the police, but the police arrived too late, and the persons passing out the handbills had gone.

In order to obtain information regarding the FPCC to turn over to authorities, he drove to the address listed on the handbill for OSWALD and located the residence 4907 Magazine Street. In order to locate the actual apartment of OSWALD, he had to make inquiry at 4907 Magazine Street and learned the apartment location of 4905 Magazine. As he started to enter the yard, OSWALD stood some distance from him and said, "Don't hit me. If you're coming as a friend, come in." OSWALD had been sitting on his front porch and was talking in another language to someone inside. He told OSWALD he had picked up a leaflet at the International Trade Mart, that he was a Cuban who had been in the country for a long time, and was interested in learning about the FPCC. NO T-5 told OSWALD that he knew about the Cubans being arrested with OSWALD, and that he did not think it was right that those persons should have been freed when OSWALD was held.

OSWALD informed him that the Cubans in the United States were all criminals and sarcastically said, "We have fine laws here." He said that FIDEL CASTRO was not a dictator, and that if the United States would invade Cuba, he would fight with CASTRO against the United States. He stated further that the press in the United States is against them (not identifying "them"), that they were in the minority today but one day would be the majority, and then all of the press would be with them. OSWALD claimed to be a student of languages at Tulane University and to be the delegate for the FPCC in New Orleans.

NO T-5 informed him that he was interested in the organization but would like to read some literature before deciding. NO T-5 was given by OSWALD a booklet on Cuba and a blank application to join the FPCC in New Orleans. These are in the possession of CARLOS BRINGUIER.
