KRYSTIAN BARCZ

[REDACTED] Dallas Council on World Affairs, 9417
Waterview Road, Dallas, Texas, on January 21, 1964 advised
KRYSTIAN BARCZ, a Polish citizen and journalist, came to
Dallas in November, 1963, after having attended a course of
training at Syracuse University. She said he was in Dallas
from about November 23, 1963 to November 30, 1963, and
came to Dallas for the purpose of observing commercial
activities being carried on at the Communications Center of
WFAA-Television and Radio. So far as she knew he did not
reside at any hotel but instead was a house guest of one
JOE GLOWACKI, identity unknown to her. He requested no
assistance from her committee while in Dallas, but did
accept one dinner invitation that was extended to him.
Mr. and Mrs. [REDACTED] Dallas, Texas
invited him to dinner one evening which was a function
planned for him by the Dallas Council on World Affairs.
He had not previously known the [REDACTED].
[REDACTED] reported concerning that dinner to [REDACTED]
after it was held. [REDACTED] does not know the means
of travel utilized by KRYSTIAN BARCZ in arriving and
departing from Dallas. She has no information indicating
he engaged in any activities detrimental to the United States.

[REDACTED], Dallas, on January
24, 1964 advised KRYSTIAN BARCZ, a young man believed 26 or
28 years of age who had been in New York State recently
with an exchange group and who is from Poland, appeared
in Dallas in November, 1963, a few days prior to the
day President KENNEDY was assassinated (November 22, 1963).
He appeared two or three times at [REDACTED]
and was [REDACTED] dinner guest there one evening. He
said BARCZ resides in Warsaw, Poland, and is the news
editor for Polish television in Warsaw. He was in Dallas
for the purpose of observing television and radio operations

at WFAA, Dallas. While in Dallas he resided at the home of JOSEPH GLOWACKI on Knox Street.

GLOWACKI and BARCZ met in the summer of 1965 in Poland while GLOWACKI was there visiting his parents who reside about eighteen miles from Warsaw.

[REDACTED] said BARCZ, through [REDACTED] became acquainted with GLOWACKI and upon coming to Dallas resided with GLOWACKI. [REDACTED] identified a photograph of KRYSZTOF BARCZ as being the individual observed by him in the company of GLOWACKI.

He understood BARCZ spent most of his time at WFAA Communications Center observing radio and television activities. While still in Dallas the assassination of President KENNEDY occurred, and two days later JACK RUBY killed LEE HARVEY OSWALD in Dallas. BARCZ was very excited when JACK RUBY reportedly had killed OSWALD and announced that he had met RUBY only a few days before that occurred. SLAWIK understood that JOSEPH GLOWACKI and BARCZ were having coffee or lunch at a restaurant in downtown Dallas a few days before the day of President KENNEDY's assassination at which time GLOWACKI happened to see JACK RUBY and introduced RUBY to BARCZ. So far as [REDACTED] knows BARCZ never knew OSWALD. After the assassination BARCZ decided to remain over in Dallas for a few more days during which time he served as a correspondent for the press and television in Warsaw. He utilized GLOWACKI's Cadillac automobile and possibly rented an automobile. He understood

BARCZ made telephone calls to the Warsaw press reporting on the news events in Dallas. [REDACTED] does not know where the telephones were located that were used by BARCZ, but presumed he used GLOWACKI's telephone at least for some of the calls.

GLOWACKI knows many persons in restaurant circles and, therefore, had become acquainted with JACK RUBY who operated two night clubs in Dallas.

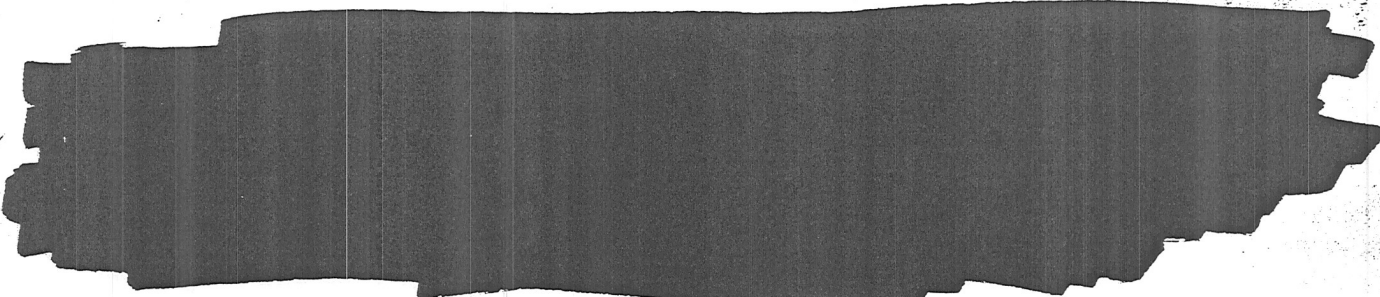

He said BARCZ left Dallas around December 1, 1963 for New York and to return to Poland.

JOSEPH A. GLOWACKI, 3442 Knox, Dallas, on December 9, 1963 advised that he was in the downtown area of Dallas on November 22, 1963 with KRYSTIAN BARCZ, a Polish National who was visiting in the United States on a State Department study grant. That afternoon they stopped at the Ritz Delicatessen for lunch and while there, he observed JACK RUBY in the delicatessen. He introduced RUBY to BARCZ and invited RUBY to sit at their table. RUBY declined with the comment that he was just

walking around. He was still at the delicatessen when they left. GLOWACKI said President KENNEDY's assassination had already occurred that day in Dallas, and RUBY asked GLOWACKI what he thought that would do to business, talking about the loss of persons coming to conventions in Dallas. GLOWACKI said he has known RUBY since about 1957 and considers him a casual acquaintance, not a friend, but had seen him often at the B & B Cafe which is near one of RUBY's night clubs. GLOWACKI said he had been in the Carousel Club of JACK RUBY on five or six occasions.
