That advertisement offered a 36 inch 5½ pound model 6.5 Italian Carbine. The rifle described by FBI Firearms Identification Expert Robert A. Krazier, on page 395 of Volume 7, with an overall length of 40.2 inches, weighing 8 pounds with scope and sling, is the model of Italia Carbine offered by Klein's in the advertisement from the Nov., 1963, issue of Field & Stream, which is for a 40 inch rifle weighing 7 pounds without scope and sling. 50 APR 13 1966



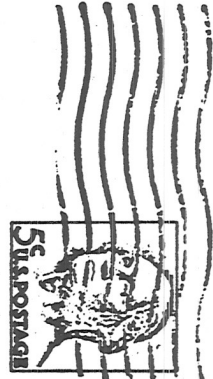
