"I REMEMBER A LOT OF THINGS WHILE I'M OUT THERE." SHE SAID. "I
REMEMBER MY SON WAS MURDERED. I REMEMBER MY SON WAS DENIED HIS
CONSTITUTIONAL RIGHTS. I REMEMBER HE WAS PROCLAIMED A KILLER ALTHOUGH
HE NEVER HAD A TRIAL."

SHE SAID SHE WAS CONVINCED "AFTER FIVE YEARS OF INVESTIGATIVE WORK BY MYSELF AND OTHERS THAT HAD MY SON LIVED HE WOULD HAVE BEEN ABLE CLEAR HIMSELF."

SHE SAID SHE WAS INTERESTED TO KNOW IF ANY OF THE THREE MAIN PRESIDENTIAL CANDIDATES WOULD BE WILLING TO REOPEN THE CASE IF THEY WERE ELECTED.
