WHILE INMATE AT [REDACTED] MET INMATE NAMED [REDACTED] AND ANOTHER INMATE NAMED [REDACTED] BOTH OF LATIN EXTRACTION. [REDACTED] STATED [REDACTED] AND [REDACTED] WERE EACH INVOLVED IN MOVEMENTS "AGAINST THE UNITED STATES" AND EACH HAD HIS OWN "POLITICAL IDEOLOGY". [REDACTED] STATED THAT

[REDACTED] TOLD HIM THAT "WE" HAD SOMETHING TO DO WITH THE ASSASSINATION OF PRESIDENT JOHN KENNEDY AND "WE" WILL GET SENATOR TED KENNEDY. [REDACTED] ALLEGEDLY WROTE LETTER TO SENATOR KIKI DE LA GARZA, ADVISING HIM OF THE ABOVE. SENATOR DE LA GARZA ALLEGEDLY CORRESPONDED WITH [REDACTED] VIA LETTER AND ADVISED [REDACTED] THAT [REDACTED] HAS ALIEN NUMBER [REDACTED] WHILE INCARCERATED AT [REDACTED]. [REDACTED] OVERHEARD [REDACTED] USE THE PHRASE "DE PARTE MI ALVENTURIO".

[REDACTED] WAS SUBSEQUENTLY TRANSFERRED FROM [REDACTED] TO [REDACTED] FOR MENTAL EVALUATIONS AND TESTING PRIOR TO BEING RELEASED. UPON ARRIVING AT [REDACTED] MET INMATE NAMED [REDACTED] ALSO OF LATIN EXTRACTION. [REDACTED] STATED THAT AFTER BECOMING ACQUAINTED WITH [REDACTED] HE ALSO HEARD [REDACTED] UTILIZE THE PHRASE "DE PARTE MI ALVENTURIO".

[REDACTED] WAS RELEASED FROM [REDACTED] DURING APRIL, 1976, AND RETURNED TO THE TEXAS AREA.

[REDACTED] STATED THAT HE IS OF THE OPINION THAT BECAUSE BOTH [REDACTED] AND [REDACTED] EACH UTILIZE THE PHRASE "DE PARTE MI ALVENTURIO", THEY ARE ASSOCIATED IN SOME WAY.

[REDACTED] STATED THAT APPROXIMATELY ONE WEEK TO TEN DAYS AGO HE WAS IN THE SHREVEPORT, LOUISIANA AREA, RESIDING AT THE

SALVATION ARMY. WHILE THERE HE CONTACTED, VIA TELEPHONE, THE SHREVEPORT OFFICE OF SECRET SERVICE REGARDING THE ABOVE, AND THAT OFFICE INSTRUCTED HIM TO CONTACT THE FBI. [REDACTED] STATED HE DID NOT CONTACT THE FBI; HOWEVER, WROTE SENATOR TED KENNEDY A LETTER, ADVISING OF THE ABOVE INFORMATION.
