RE: ASSASSINATION OF PRESIDENT
JOHN F. KENNEDY
NOVEMBER 22, 1963
DALLAS, TEXAS
ASSAULTING A FEDERAL OFFICER

On September 6, 1978, [REDACTED] telephonically contacted the Wilmington, Delaware, Office of the FBI. [REDACTED] at that time stated that he wished to provide information which could possibly pertain to the assassination of President JOHN F. KENNEDY.

On September 8, 1978, [REDACTED] was interviewed by an agent of the Dover, Delaware, Resident Agency of the FBI at [REDACTED]. [REDACTED] stated that sometime during 1965 or 1966 he was contacted by two men who identified themselves as a Central Intelligence Agency agent and an agent of the Army Intelligence Division. [REDACTED] stated that the agents displayed identification from their respective agencies and advised him that they wished to ask him questions regarding [REDACTED]. [REDACTED] stated that he was told by the agents that [REDACTED] was being considered for a position with the Army Intelligence Division and that the questions they wished to ask were part of a background investigation. [REDACTED] stated that he was asked questions regarding [REDACTED] personal habits and whether or not he, [REDACTED] lived within his means. b7c b7D

[REDACTED] further advised that after concluding questions regarding [REDACTED] the agents questioning him asked that [REDACTED] not make any mention of the interview. [REDACTED] then stated that a year or more after being questioned by the above-mentioned agents, he began to suspect that they, the agents, may have been investigating [REDACTED] as a suspect in the assassination of President JOHN F. KENNEDY.

██████████ stated that he has known ██████████ years. ██████████ stated ██████████ is a member of the Delaware National Guard and he is qualified as an expert marksman. ██████████ further stated that ██████████ is a gun collector.

██████████ advised that in trying to recall the events which took place at the time President KENNEDY was assassinated, he recalls that ██████████ was in Texas for a one-month period sometime within a year of the KENNEDY assassination. ██████████ had been told by ██████████ that the reason for his trip to Texas was to attend a school for the National Guard.

██████████ advised that he has no firm reason to believe ██████████ had anything to do with the KENNEDY assassination but that he, ██████████ has a "gut feeling". ██████████ reiterated that he is not even certain of the dates during which ██████████ was in Texas.

██████████ stated that during ██████████ years he has known ██████████ he has never been aware of any violent acts committed by ██████████ and has never known ██████████ to illegally use a firearm.
