CHUCK ROLLAND, WINTERLAND SKATING RINK, HOUSTON, ADVISED MAN INTRODUCING HIMSELF AS FERRIS OR FERRIE CONTACTED HIM BY TELEPHONE NOVEMBER TWENTYTWO, LAST AND ASKED SKATING SCHEDULE AT WINTERLAND SKATING RINK. ON NOVEMBER TWENTYTHREE, LAST, BETWEEN THREE THIRTY AND FIVE THIRTY PM, FERRIE AND TWO COMPANIONS CAME TO WINTERLAND SKATING RINK AND TALKED TO ROLLAND IN SHORT GENERAL CONVERSATION, BUT AT NO TIME DID THEY DISCUSS COST OF EQUIPPING OR OPERATING ICE SKATING RINK.
