THE NEW ORLEANS TIMES-PICAYUNE NEWSPAPER DATED
MAY SIXTEEN, SIXTYSEVEN, CARRIES AN ARTICLE WHICH
STATES THAT ON MAY SIXTEEN, SIXTYSEVEN, AN ATTORNEY
FOR CLAY L. SHAW, ACCUSED PRESIDENTIAL ASSASSIN ^{ASID}
THAT THE FIGURE P. O. ONE NINE ONE ZERO SIX IN LEE
HARVEY OSWALD'S ADDRESS BOOK WAS A TELEPHONE NUMBER IN
RUSSIA. THE ARTICLE NOTED THAT DA JAMES GARRISON HAD
PREVIOUSLY SAID THAT THE NUMBER WAS A CODE FORM FOR
JACK RUBY'S NINETEEN SIXTYTHREE UNLISTED TELEPHONE
NUMBER IN DALLAS AND THAT THE SAME FIGURE EXISTS IN SHAW'S
SEIZED ADDRESS BOOK.

THE ARTICLE STATED THAT THE FIGURE IN SHAW'S BOOK WAS LISTED TO LEE ODOM OF DALLAS, TEXAS, WHOM SHAW SAID HE MET IN NINETEEN SIXTYFIVE.

SHAW'S DEFENSE ATTORNEY, SALVADOR PANZECA, ACCORDING TO THE ARTICLE, STATED THE DEFENSE WILL PROVE THAT THE LISTING BY OSWALD WAS A RUSSIAN PHONE NUMBER AND WILL BRING ODOM INTO COURT.

THE ARTICLE ALSO MENTIONED THAT ALVIN R. BEAUBOEUF, PREVIOUSLY IDENTIFIED AS A FRIEND OF DAVID WILLIAM FERRIE, WENT TO THE POLICE BUREAU OF INVESTIGATION TO FILE A COMPLAINT IN CONNECTION WITH AN ALLEGED BRIBERY ATTEMPT BY TWO OF GARRISON'S POLICE INVESTIGATORS. THE ARTICLE SAID BEAUBOEUF WAS ACCOMPANIED BY HIS ATTORNEY, BURTON KLEIN, WHO FIRST DISCUSSED THE MATTER WITH SUPERINTENDENT OF POLICE JOSEPH I. GIARRUSSO ON MAY FIVE, SIXTYSEVEN. THE ARTICLE NOTED THAT IT WAS THE FIRST TIME BEAUBOEUF APPEARED TO MAKE A FORMAL COMPLAINT.

THE NEW ORLEANS STATES ITEM, RED COMET EDITION, DATED MAY SIXTEEN, SIXTYSEVEN, CARRIES AN ARTICLE WHICH STATED THAT FBI AGENT REGIS KENNEDY IS TO GET HIS DAY IN COURT ON MAY SIXTEEN, SIXTYSEVEN, ON A MOTION TO SET ASIDE A GRAND JURY SUBPOENA ISSUED TO KENNEDY IN ADA GARRISON'S ASSASSINATION PROBE.

THE ARTICLE SAID THAT GARRISON'S OFFICE WAS EXPECTED TO FILE A LENGTHY ARGUMENT IN CRIMINAL DISTRICT COURT SEEKING TO FORCE KENNEDY'S APPEARANCE BEFORE THE ORLEANS PARISH GRAND JURY.

THE ARTICLE ALSO NOTED THAT A FORMER AGENT, WARREN DEBRUEYS, WHOSE NAME ALSO APPEARS FREQUENTLY ON FBI-WARREN COMMISSION REPORTS, WAS ALSO ISSUED A SUBPOENA, BUT WAS NEVER SERVED, BEING REPORTEDLY OUT OF TOWN.

THE ARTICLE CONTINUED THAT IF THE SUBPOENA FOR KENNEDY IS UPHELD BY JUDGE BERNARD J. BAGERT, GARRISON'S OFFICE COULD ASK FOR A SUBPOENA INSTANTIS TO BE SERVED ON KENNEDY REQUIRING HIM TO APPEAR BEFORE GRAND JURY ON MAY SEVENTEEN NEXT.

THE ARTICLE ALSO REVEALED THAT THE GRAND JURY ON MAY SEVENTEE, NEXT IS SCHEDULED TO RECEIVE A RETURN ON A SUBPOENA DUCES TECUM DELEIVERD LAST WEEK TO CIA DIRECTOR RICHARD HELMS, IN CONNECTION WITH THE DA'S REQUEST FOR HELMS TO SEND TO NEW ORLEANS A PHOTOGRAPH TAKEN BY THE CIA IN MEXICO CITY A FEW DAYS BEFOR THE ASSASSINATION.

THE ARTICLE ALLEGES THAT GARRISON STATES THE PICTURE SHOWS LEE HARVEY OSWALD WALKING OUT OF THE CUBAN EMBASSY IN MEXICO CITY WITH A POWERFILLY BUILT CUBAN.
