Synopsis: The Federal Grand Jury (FGJ), NDT, Dallas, Texas, heard testimony from witnesses concerning the Obstruction of Justice aspects of this case on 5/1, 5/2, 5/14, 5/22 and 7/16-18/75.

The FGJ, Dallas, returned a true bill indictment on 7/21/75 charging NELSON BUNKER HUNT with one count of Conspiracy to Obstruct Justice (COJ) and six counts of Obstruction of Justice (OOJ); W. HERBERT HUNT with one count of COJ and six counts of OOJ; RALPH SHANK with one count of COJ and six counts of OOJ; CHARLES TESSMER with one count of COJ, one count of OOJ and two counts of Perjury; B.H. TIMMINS, JR. with one count of COJ and one count of OOJ; PERCY FOREMAN with one count of COJ and two counts of OOJ and EDWARD J. HUDSON with one count of COJ and two counts of OOJ. On 8/1/75, NELSON BUNKER HUNT, W. HERBERT HUNT, CHARLES TESSMER, B.H. TIMMINS, JR. and RALPH SHANK were arraigned before US District Judge HALBERT O. WOODWARD, NDT, Dallas, and all pled not guilty to the FGJ indictment of 7/21/75. USDJ WOODWARD, NDT, Lubbock, Texas, scheduled the trial in the case of U.S. Vs. NELSON BUNKER HUNT and W. HERBERT HUNT for 9/15/75 at Lubbock, Texas.
