commence in United States District Court (USDC), Dallas, Texas, before United States District Judge (USDJ) HALBERT O. WOODWARD on charges of Obstruction of Justice and Conspracy on April 19, 1976. On the morning of April 19, 1976, USDJ WOODWARD severed EDWARD J. HUDSON and PERCY FOREMAN from the trial. Judge WOODWARD had previously severed RALPH SHANK from the trial and had also previously severed the two perjury counts on CHARLES TESSMER.

On the evening of April 19, 1976, NELSON BUNKER HUNT, CHARLES TESSMER and B. H. TIHMINS, JR. each pled nolo contendre to an information charging them with a violation Title 18, U. S. Code, Section 401 (Contempt). Judge WOODWARD fined each \$1,000 and dismissed the charges on them as set forth in the Federal Grand Jury (FGJ) indictment of July 21, 1975. Judge WOODWARD also dismissed all the charges in the FGJ indictment against W. HERBERT HUNT.

On April 27, 1976, RALPH SHANK pled nolo contendre to an information charging him with violation Title 18, U. S. Code, Section 401 (Contempt) in USDC, Dallas, Texas. USDJ HALBERT O. WOODWARD fined SHANK \$1,000 and dismissed the charges in the Federal Grand Jury indictment of July 21, 1975 against him.
