- I. Support official "line assessment - no conspiracy" line
- II. Put down "critics" ~~dismissing~~ <sup>dismissing</sup> all together
- III. B. Justify itself & largest investigative apparatus in Congressional history by pretending it has "new evidence" and ~~is~~ with plenty of criticism of federal agencies & Warren Commission

- 1. A. Never considered anyone other than LHO as assassin & pretended search for possible co-conspirators - check reports, House speeches, other statements
- B. Never investigated other than in pattern of earlier official investigations
  - 1) no investigation of planting "magic" bullet
    - a) never raised any question of absence of metal data - mentioned only deppmity
  - 2) no investigation of (rarely mentioned) "missed" shot
    - a) Has not even spoken to Jim Teague <sup>slightly wounded</sup>
  - 3) no mention missing carbstone "spectro" plate - (This is totally new & never published - learned in lawsuit)
  - c) no mention carbstone analysis does not hold all my use of bullet - only 2 - of those could have come from auto wheel weight.
  - d) no NAA's on upper alloy jacket material of bullet, which our report said is superior for test my purposes - I'd paid for study
  - e) ignored dis appearance of G-15 wood shield sample
  - f) Did not report the specimens not identical with FBI/Warren ones - given in apt 2 testimony. Did not ask Gurney any questions about these differences

- F. Said Commission did not have and open proof

 1. Sec. statement on X-ray  
 2. Ex. Sec. on proof
- G. - Pretended Bobby Kennedy withheld this  
 1.) J.P. Commission never asked  
 (Spitzer memo in Post mortem)
- 2) Basic summary in evidence - Gunn/NAA, incomplete  
 & he was of the use not truthful
- A. Testified "results" were thorough, he knew  
 specimens not identical & did ~~test~~  
 but one did not exist when he announced  
 the rule  
 1) did not question whether he was given fakes  
 a) One possibility is from box of 399  
 which is not accounted for / spelled out  
 details  
 2) no coffee - just testimony although he testified  
 Woffen is one of 3 best elements for NAA
- B. Testified was not fully aware  
 1. His knowledge of when FBI did NAA's

- C. No reference to spectrographic analyses

- C) Nervous reaction shows in Zap film
  - 1) Whitworth is source, not always, plus got info from students who read book (Always paid by ERPA)
- D) From 1980 by post but - WW
- E) JFK hit before 210 - at 200
  - 1) Whitworth II
  - 2) Uses same means of establishing
    - a) WW is 5 ft
    - b) Zap
    - c) Oppenheimer as question point in pictures
