

Thank you for your letters of May 25 and June 16, and for the copies of Warren Commission records. As suggested in your letter of May 25, I have written to the Louisiana Department of Public Safety concerning the withheld pages in CD 365.

Please send me an 8½ by 11" Xerox copy of each of the following items:
The synopsis only for CD's 55, 58, 171, 177, 226, 233, 256, and 314.

I am also interested in an interview with Mr. Joseph Goulden, which I believe should be in one of these eight CD's. If you could look over the synopses and send me any such interviews which are mentioned there, that would be greatly appreciated.

CD 325, pages 3-7

CD 637, pages 1-2, 9-10, 12-13.

By letter of October 30, 1968 to Mr. James Schmitt, you advised that you had been unable to locate the enclosures mentioned in CE 3146, which was apparently not made into a CD. I asked the Justice Department for access to these items under the Freedom of Information Act, but did not ask for copies. On July 22, 1970, Deputy Attorney General Kleindienst wrote me that "we shall communicate with appropriate personnel at the National Archives to explore the possibility of furnishing these items to the Archives for the completion of their files." Could you tell me if you now have all of the enclosures to this CE? If so, please send me a copy of the first two pages and the last two pages of the memorandum dated September 14, 1964.
