Interviewed in the Bluffs inday afternoon, Mr. Beckem said he aided Sergio reachay Smith of Dallas in ising funds by obtaining colction cans and designing a bel for the cans.

In a previous interview Mr. eckham denied knowing Mr. reacha.

Mr. Beckham said the detective agency was in or near 531 Lafayette Street.

Mr. Garrison said that Mr. Beckham "associated with David Ferrie and others at 531 Lafayette Street, which was the same office building described as 544 Camp Street, the address originally used on leaflets handed out by Lee Oswald in New Orleans." Oswald was named by the Warren Commission as the as-

sassin of President Kennedy.

But Sunday Mr. Beckham repeated his denial that he ever knew Oswald. He also denied that he had ever met with Mr. Ferrie more than once, and said that meeting was only for 10 minutes.

Mr. Beckham also repeated his contention that Mr. Garrison should subpoena Jack S. Martin, Sr., a private investigator in New Orleans, because he knew many of the people sought to testify in the Garrison investigation. He said it was through Mr. Martin that he met Mr. Ferrie.
