No 1... I don't believe that any person that was on the scene at that time that the actual shot was fired, could say with any certainty that it came from that room, window because I did not talk to anyone that actually saw the shot fired, myself.

DAVID:

So if nobody who was immediately around saw anybody, who they could identify definitely as James Earl Ray at the time, and if no-one's exactly sure where the shot came from, there's still very many questions about the whole case.

CAPT SMITH:

Well as far...as far as I know they the problem's been tried to be resolved one way or the other now, my personal knowledge of it I would eh, certainly like to see the km factual account of it eh, but if that's ever available I would be glad to have a look at it.
