Dear Mr. King,

If health problems had not prevented it I'd have written you as soon as ~~you~~  
you and your mother came out for a trial for James Earl Ray. I write now, in  
violation of doctor's orders, in the belief I can inform you and to encourage  
you not to expect too much, perhaps not to expect the impossible, should Ray  
be granted a trial. Aside from what I learned in writing my book Frame-Up:  
the Martin Luther King/James Earl Ray Case and what thereafter I learned as  
Ray's investigator, I filed FOIA lawsuits against the government and got about  
80,000 pages of what had been secret records. You and your center are welcome,  
by the way, to copies of any of this and nothing will ~~be~~ be asked in return.

Most of my work has been on the JFK assassination. I wrote the first  
book and I think eight or nine published since then and do not have a single  
letter or phone call from any of those of whom I wrote so critically complain-  
ing of unfairness or inaccuracy by any one of them. There was so many similar-  
ities that after your father was assassinated I used FOIA to obtain information  
about that crime and I add its official investigation.

I conducted the investigation for the habeas corpus, in which we succeedd  
and then for the two weeks of ~~ad~~ <sup>which</sup> adentiary hearing in ~~which~~ the phony liberal  
judge found in contradiction to all the evidence and denied the trial. He did  
use the words "guilt or innocence" were "immaterial" to what was before him,  
whether Ray had been coerced into his plea and whether he had had the "effective  
assistance of counsel." I have <sup>those transcripts</sup> ~~those transcripts~~ and if you'd like you can  
copy them. I think you should want them. They are the <sup>only</sup> ~~one~~ addressing of the  
alleged official evidence under oath in a federal court.

Resumed 3/2. Sorry I had to suspend. Please read my enclosed letter to the Wash. Post  
about its <sup>of</sup> today's dishonesties.

As best I can now recall after all those years the SCLC was persuaded by  
the Department of Justice, possibly by Assistant Attorney <sup>General</sup> ~~Genral~~ Vinson, that  
they had a solid case against Ray and that he would be electrocuted unless he  
copped a plea. In fact they had no case at all against Ray, which is still true,

and they could prevent the disaster of taking a case to court only by getting  
Ray to agree to a plea. There was <sup>no</sup> chance at all in <sup>those</sup> ~~these~~ days of his being electro-  
cuted.

When my book was out I tried to interest the SCIC and got nowhere. Ditto for the Black Caucus in Congress, other than <sup>John</sup> Conyers, who was fine. I sent copies of the book to Atlanta and others also did. No reaction. The chief lawyer wrote or spoke to your mother for me. We were referred to Mr. Wachtel in New York. I went up and got no farther than the reception desk. Later he had a law student phone me. He never spoke to me or saw me at all or looked at any evidence.

I know nothing about this alleged new test but as of several decades ago it was ~~not~~ necessary.

I have no doubt ~~if~~ there was the person "ay" refers to as "oual" <sup>R</sup> and he refused absolutely to give me any leads on it. I therefore do not believe that he will come up with any now, not any real ones. Or, base no hopes on that or on anything like it.

I doubt he had any real identification anyway.

There seems to be some black assumption of Ray's guilt. I am convinced he was not part of any conspiracy to kill your father of which he knew. Curtis in the McMillan book made it all up and much is ridiculous. Byers did get leniency for a major crime. I've forgotten the details but he lied. As so many did hoping for consideration in return.

I ask nothing of you. You are welcome to all of this if you want any of it. It is, I fear, as close to the <sup>to fact</sup> truth as will be possible because the crime itself was never investigated. It will all be a public archive at local Hood College and if you want any information about me I suggest you ask the history professor there who will be in charge of that archive, Dr. Gerald <sup>Knight</sup> Knight. His office phone is 301/696-3720. His home phone is 301/473-5639.

I did not continue with ~~this~~ this work and returned to my work on the JFK assassination because I could not develop any interest on the part of any black person. Other than John Conyers.

If you are a lawyer or would care to have one look at it I suggest you ask Justice for the file of what it gave London to get "ay" extradited. It is public although when I saw it was marked secret. No case at all. They even pretended that the assassination was not a political crime. It was disclosed to me in CA 718-70. I do not have the copies I used in the book but they are required to give that file to you if you ask for it under FOIA because it is disclosed, is now public information.

Sorry I cannot now be of more help.
