I just heard from my parents that my dad's angioplasty (balloon used to press down blockage in arteries) didn't work and he's going to have a bypass on MondayTuesday 27/28 of May. It's not good news, but hopefully he'll come through it OK. His athletics are very important to him and hopefully he'll be able to resume them.
