UPHOLDS CONVICTION ON WEAPONS CHARGE

CHICAGO, Dec. 6 - A fireerms conviction against Richard Lauchli Jr., Collinsville, Ill., once a leader of the Minutemen in Illinois, was upheld yesterday by the Seventh United States Circuit Court of Appeals here.

In his appeal, Lauchli contended that Treasury agent Fortino Gutierrez was guilty of entrapment because he posed as an exile Cuban general trying to buy arms. A unanimous opinion written by Judge F. Ryan Duffy discounted the contention of entrapment.

Lauchli was sentenced to two and a half years in prison on a charge of manufacturing firearms without paying a tax on the arms or registering them. In addition, he was given a suspended two-year sentence on a plea of guilty of stealing 23 bazookas from the Jefferson Proving Ground, Madison, Ind.

JOPLIN, Ma., Mar. 12 (AP) -A former Minuteman testified vesterday that he sold and shipped a 50-caliber machine gun to a Joplin man in 1965. Richard A. Lauchli Jr., 40 years old, Collinsville, M., gave the testimony in his trial before Judge William Collinson in United States District Court. Lauchli was charged with transferring a machine gun to a Joplin purchaser May 27. 1965, without having bought a special Treasury Department tax stamp. He testified that he sold the weapon without a firing pin and considered it to be a war trophy or souvenir. He had been tried in Joplin earlier this month before Judge Collinson. The judge ordered the serving of the 18-month sentence to begin after Lauchli findshes the 21/2-year term in the federal prison at Terre Haute, Ind.
